NOTICE IS HEREBY GIVEN that on the 15th day of February 2024 Cornwall Council made the above Order operational from 26th day of February 2024 to regulate traffic in Newquay. The effect is to introduce and amend waiting restrictions as specified below.

Any person wishing to question the validity of the Order or any provision thereof on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 or that a requirement of that Act or any relevant regulation made thereunder has not been complied with may, within 6 weeks from 15th February 2024, make application for the purpose to the High Court.

NEWQUAY

No waiting at any time

Albany Road outside No 1; **Alexandra Road** at junction with Watergate Road; **Chester Road** sections from junction with Hilgrove Road to No 16; **Chester Road (West Arm)** at junction with Hilgrove Road; **Chichester Crescent** at junction with Mellanvrane Lane; **Edgcumbe Avenue** opposite No 39; **Lewarne Road** at junction with Porth Bean Road; **Mellanvrane Lane** at junctions with Trevemper Road, Chichester Crescent and Treforda Road; **Mellanvrane Lane (north-west arm)** at junction with Trevemper Road; **Porth Bean Road** at junction with Lewarne Road; **Riverside Crescent** outside No 2; **Tolcarne Mews** at junction with Tolcarne Road; **Tolcarne Road** sections between Albany Road and Tolcarne Mews and access to The Old Gas Works; **Treforda Road** at junctions with Mellanvrane Lane and Treninnick Hill; **Treloggan Industrial Estate** sections along its length; **Treninnick Hill** at junction with Treforda Road; **Trevelgue Road** at junction with Alexandra Road; **Trevemper Road** at junction with Mellanvrane Lane; **Watergate Road** sections between junction with Trevelgue Road and north-eastern junction with Watergate Road (service road); **Watergate Road (service road)** for its entire length (western side) and at access to High Atlantic.

Edgcumbe Avenue sections between Nos 2-60 and opposite No 41-45; **Tolcarne Road** outside Rebellion Roast House and between Nos 4-12.
