

**The County of Cornwall (Penzance) (Various Streets)  
(On-Street Parking Places and Restrictions on Waiting)  
(Amendment) Order 2015**

Cornwall Council in exercise of its powers under Sections 1,2, 32 and 35 (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. The Order shall come into force on the <sup>19<sup>th</sup></sup> day of *November* 2015 and may be cited as "The County of Cornwall (Penzance) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Amendment) Order 2015".

2. The County of Cornwall (Penzance) (Holly Terrace, Heamoor) (Disabled Persons Street Parking Place) Order 2006 is hereby deleted.

3. The County of Cornwall (Various Streets) (Disabled Persons Street Parking Place) Order 2009 shall have effect as though:

4. The County of Cornwall (Penzance) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2010 shall have effect as though:
