The County of Cornwall (Penryn) (Various Streets) (Restrictions on Waiting) (Amendment) (Part 2) Order 2023

THE CORNWALL COUNCIL in exercise of its powers under Sections 1, 32, 35, 45, 46 and 49 of (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. This Order shall come into force on the $\sqrt{8}^{48}$ day of $\sqrt{2025}$ and may be cited as "The County of Cornwall (Penryn) (Various Streets) (Restrictions on Waiting) (Amendment) (Part 2) Order 2023".

2. In this Order, except where the context otherwise requires, the following expressions have the meanings hereby respectively assigned to them:

"enactment" means any enactment whether public, general or local, and includes any order, byelaw, rule, regulation, scheme or other instrument having effect by virtue of an enactment;

"Map Schedules" means the plans, including their keys, annexed to The County of Cornwall (West Central Cornwall) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2024; and

"Map Tiles" means the plans, including their keys, contained in the Schedule to this Order.

3. Unless expressly stated to the contrary, any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated or reenacted by, or as having effect by virtue of, any subsequent enactment.

4. Save as provided in Article 5, the Map Schedules are hereby varied to the extent shown on the Map Tiles.

5. Any existing prohibitions, restrictions or designations applying to any lengths of road or sides of any lengths of road prior to this Order coming into force, which are not referenced on the Map Tiles, shall be deemed to be excluded from the aforementioned variation.

6. The County of Cornwall (West Central Cornwall) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2024 shall have effect as though:

In Article 2.2 the paragraphs relating to the expressions "**pedestrian zone**" and "**pedestrian and cycle zone**", "**restricted parking zone**", and "**shared**", were deleted and replaced with the following:

"pedestrian zone" and "pedestrian and cycle zone" have the same meanings respectively as in Schedule 1 of The Traffic Signs Regulations and General Directions 2016, and when used in the key on a Map Schedule both expressions refer to lengths of road over which multiple restrictions, prohibitions and/or designations are present which should be read in addition to, and not in derogation of, each other, and where the specified periods shown for each on that Map Schedule overlap, such shall operate concurrently;

"restricted parking zone" has the same meaning as in Schedule 1 of The Traffic Signs Regulations and General Directions 2016, and when used in the key on a Map Schedule refers to lengths of road or sides of lengths of road over which multiple restrictions, prohibitions and/or designations are present which should be read in addition to, and not in derogation of, each other, and where the specified periods shown for each on that Map Schedule overlap, such shall operate concurrently;

"shared" in the key on a Map Schedule refers to lengths of road or sides of lengths of road over which multiple restrictions, prohibitions and/or designations are present which should be read in addition to, and not in derogation of, each other, and where the specified periods shown for each on that Map Schedule overlap, such shall operate concurrently;

The following was inserted after Article 5.2:

5.3 In so far as any other restriction, prohibition or designation provided for by this Order conflicts with an area wide waiting restriction contained within a "**pedestrian zone**", "**pedestrian and cycle zone**", "**restricted parking zone**" or "**shared**" area, by imposing, removing, altering, or granting exemption from any prohibitions or restrictions on waiting or any conditions thereof, then during the operating hours of the other, the conflicting area wide waiting restriction shall be deemed not to apply for the extent of the conflict.

In Article 7.13(a) after the words "Resident permit holders parking place" the following words were added: "or permit parking area".

Articles 7.13(b) & (c) were deleted and replaced with the following:

(b) In so far as any other restriction, prohibition or designation provided for by this Order conflicts with a designated Resident permit holders parking place or permit parking area, by imposing, removing, altering, or granting exemption from, any prohibitions or restrictions on waiting or any conditions thereof, then except where the vehicle is to be treated as waiting in a Resident permit holders parking place or permit parking area in line with Articles 7.13(c) the other provision shall prevail for the extent of the conflict.

(c) A vehicle shall be treated as waiting in a Resident permit holders parking place or permit parking area, and exempt from any other restriction or prohibition on waiting, if:

- (i) the length of road or side of the length of road in which the vehicle is waiting is identified in the Map Schedules as a Free parking place;
- (ii) the Free parking place is identified in the Map Schedules as being located within a Resident permit holders parking place or permit parking area;
- (iii) the vehicle is waiting during the chargeable hours of the Resident permit holders parking place or permit parking area;
- (iv) the length of road or side of the length of road on which the vehicle is waiting has been signed indicating that either waiting by permit holders or limited waiting is permitted; and
- (v) the vehicle is complying with the conditions outlined in Article 7.13(a) for waiting in a Resident permit holders parking place or permit parking area.

(d) Except where provided by Articles 7.13(b) and (c), any Resident permit holders parking place or permit parking area restriction shall be read in addition to, and not in derogation, of any other prohibition, restriction or designation, and both shall operate concurrently during its chargeable hours.
