

**The County of Cornwall (Penwith) (Connor Downs, Lelant and Reawla)  
(Restrictions on Waiting) (Amendment) Order 2019**

Cornwall Council in exercise of its powers under Sections 1, 32 and 35 of (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. The Order shall come into force on the *1<sup>st</sup>* day of *April* 2021 and may be cited as 'The County of Cornwall (Penwith) (Connor Downs, Lelant and Reawla) (Restrictions on Waiting) (Amendment) Order 2019'.
2. The County of Cornwall (Kerrier) (Rural Settlements) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2010 shall have effect as though:

3. The County of Cornwall (Various Streets) (Disabled Persons Street Parking Place) Order 2009 shall have effect as though:

**The sections relating to Goldsithney and St Buryan were deleted.**

4. The County of Cornwall (Penwith) (Rural Settlements) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2009 shall have effect as though:
