

**The County of Cornwall (Penzance) (Various Roads)
(Restrictions on Waiting) (Experimental) Order 2023**

THE CORNWALL COUNCIL in exercise of its powers under Section 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. This Order shall come into force on the 2nd day of February 2023 for a period of eighteen months and may be cited as "The County of Cornwall (Penzance) (Various Roads) (Restrictions on Waiting) (Experimental) Order 2023".
2. In this Order:
 - i. any reference to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated or re-enacted by or as having effect by virtue of any subsequent enactment.
 - ii. "enactment" means any enactment whether public, general or local and includes any byelaw, rule, regulation, scheme, or other instrument having effect by virtue of an enactment.
3. In so far as any provision of this Order conflicts with any provision of any Order previously made or having effect as if it were previously made under the Act of 1984 and which imposes a restriction or prohibition on vehicles or grants an exemption from such restriction or prohibition then that provision of this Order shall prevail.
4. Except where provided by Article 3, the prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation of any other prohibition or restriction whether made under the Act of 1984 or otherwise.
5. The Head of Highways and Infrastructure at Cornwall Council, or a person authorised by him, may modify or suspend the operation of this Order or any provision of it, if it appears to him essential:
 - i. in the interests of the expeditious, convenient and safe movement of traffic,
 - ii. in the interests of providing suitable and adequate on-street parking facilities, or
 - iii. for preserving or improving the amenities of the area through which any road affected by the Order runs.
6. The County of Cornwall (Penzance) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2010 shall have effect as though:

In the Third Schedule relating to No waiting at any time:

The paragraph relating to Barwis Hill was deleted and replaced with the following:

Barwis Hill (U6007)		both sides
	(i)	from its junction with Penare Gardens / Penare Terrace for a distance of 6 metres in a south-westerly direction

Paragraphs 32(b) and (d) were deleted and replaced with the following:

32. Chywoone Avenue (U6003)	(b)	south side
	(i)	from its junction with Chywoone Hill to a point 3 metres east of the eastern boundary of No 40
	(ii)	between points 2 metres south-west and 18 metres north-east of the south-western boundary of No 64

In the paragraph relating to Empress Avenue (a)(i) was deleted and replaced with the following:

Empress Avenue (U6007)	(a)	north-east side
	(i)	from its junction with Coombe Road for a distance of 22 metres in a south-easterly direction
	(b)	south-west side
	(ii)	from its junction with Rosevean Road to the western building boundary of Nos 1 & 1a Rose Terrace

In the paragraph relating to Penare Terrace the following was inserted:

Penare Terrace (U6007)	(c)	north-west side from a point 6 metres south-west of the north-eastern boundary of No 1 The Mews to a point 9 metres south-east of the north-western boundary of that property
	(d)	south-east side from a point opposite a point 6 metres south-west of the north-eastern boundary of No 1 The Mews to its junction with Road from Penare Terrace to Lannoweth Road
