

THE COUNTY OF CORNWALL (PORTHTOWAN AND MOUNT HAWKE)
(RESTRICTIONS ON WAITING) (AMENDMENT) ORDER 2012

Cornwall Council in exercise of its powers under Sections 1, 2, 32 and 35 of (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. The Order shall come into force on the 24th day of May 2013 and may be cited as "The County of Cornwall (Porthtowan and Mount Hawke) (Restrictions on Waiting) (Amendment) Order 2012"
2. The County of Cornwall (Carrick) (Rural Settlements) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2010 shall have effect as though:

After Article 3.1.14 the following was inserted:

3.1.15 between 9am to 6.30pm 1st May to 30th September in the lengths of road specified in the Twenty-Fourth Schedule to this Order.

MOUNT HAWKE

In the Second Schedule relating to No Waiting at Any Time the following paragraphs were inserted:

Roddas Road		south-east side from the western side of the school entrance for a distance of 13 metres in a south-westerly direction.
Road from Fore Street to junction north of Pen Hallow Close (C0294)	(i)	south-east side from its junction with Trenithick Meadow to the eastern side of the school entrance.
	(ii)	from its junction with Trenithick Meadow for a distance of 13 metres in a north-easterly direction.
Trenithick Meadow (U6056)	(a)	north-east side from its junction with the road from Fore Street to junction north of Penhallow Close for a distance of 39 metres in a south-easterly direction.
	(b)	south-west side from its junction with the road from Fore Street to junction north of Penhallow Close to its junction with Trenithick Meadow (south-west spur road).



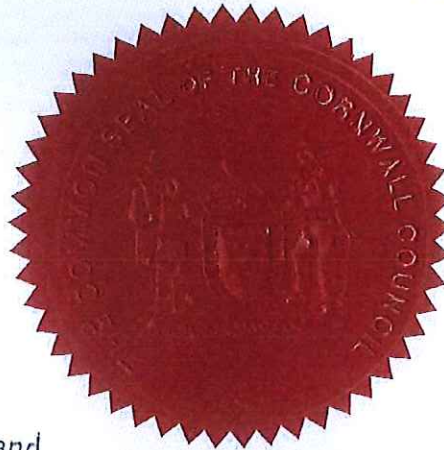
