

The County of Cornwall (Redruth) (Various Streets) (On Street Parking Places and Restrictions on Waiting) (Amendment) Order 2017

Cornwall Council in exercise of its powers under Sections 1, 2, 23 and 35 of (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. The Order shall come into force on the 26th day of April 2018 and may be cited as The County of Cornwall (Redruth) (Various Streets) (On Street Parking Places and Restrictions on Waiting) (Amendment) Order 2017.
2. The County of Cornwall (Redruth) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2010 shall have effect as though:

Article 3.2.2 was deleted.

In the Second Schedule relating to no waiting at any time:

In paragraph 4 the following was inserted:

 - (b) south-west side
 - (iii) from the north-western boundary of no.79 to the south-eastern boundary of no.81.

Paragraph 31 was deleted and replaced with the following:

31. Gweal Pawl (U6)
- both sides
 - from its junction with the access road between nos.11 and 12 to a point 4 metres west of its junction with the access road leading to the garages of nos. 1-4.

In paragraph 49 the following was inserted:

49. Park Road (U6049)
- (a) both sides
 - (ii) from a point 12 metres north-east to a point 10 metres south-west of its junction with Albany Road.
 - (b) north-west side
 - from a point 60 metres north-east of its junction with Albany Road for a distance of 10 metres in a north-easterly direction.

In the paragraph relating to School Lane, (a) (iii) and (b) were deleted and replaced with the following:

- School Lane (U6051)
- (b) north-east side
 - from its junction with East End to a point 12 metres east of its junction with Lowarthow Marghas.

In paragraph 69 the following was inserted:

69. St Day Road (C0073)
- (e) north side
 - from its junction with Highland Park for a distance of 28 metres in a westerly direction.

In the paragraph relating to West Trewirgie Road the following was inserted:

- West Trewirgie Road (U6044)
- (a) north side
 - (ii) from its junction with Coach Lane to a point 3 metres east of the western building boundary of no.14 Higher Sentry.
 - (b) south side
 - (ii) from its junction with Trevingey Road to the boundary of Bedford House and Endsleigh.

The following new paragraphs were inserted:

Coach Lane (U6044)	both sides from its junction with Trevingey Road/West Trewirgie Road to the northern side of the footpath known as Church Lane.
Gilly Hill (U6044)	both sides from its junction with Falmouth Road for a distance of 10 metres in a south-westerly direction.
Gweal Pawl (access road to Blowinghouse Hill) (U6)	both sides from its junction with Blowinghouse Hill to its junction with Gweal Pawl.
Highland Park (U6049)	west side from its junction with St Day Road for a distance of 12 metres in a northerly direction.
Trevingey Close (U6044)	north-west side from a point 47 metres west of its junction with Trevingey Parc for a distance of 39 metres in a westerly then southerly direction.
Trevingey Road (U6044)	both sides from its junction with Coach Lane/West Trewirgie Road for a distance of 14 metres in a westerly direction.
Unnamed unadopted Access road leading to Trevingey Farmhouse	west side from its junction with Trevingey Close for a distance of 3 metres in a northerly direction.

In the Sixth Schedule relating to No Waiting Mon-Sat 9am-6pm:

Paragraph 5 (a) (ii) relating to Falmouth Road was deleted.

Paragraph 5 (b) was deleted and replaced with the following:
