

**The County of Cornwall (Restormel) (Penhale, St Dennis and Trethurgy)
(Restrictions on Waiting) (Amendment) Order 2021**

The Cornwall Council in exercise of its powers under Sections 1, 32 and 35 of (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. This Order shall come into force on the ^{4th} day of January 2023 and may be cited as "The County of Cornwall (Restormel) (Penhale, St Dennis and Trethurgy) (Restrictions on Waiting) (Amendment) Order 2021".
2. The County of Cornwall (Restormel) (Rural Settlements) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2010 shall have effect as though:

FRADDON

The following new paragraphs were inserted:

B3275 from New Road to Penhale (B3275)	(a)	north-west side

	(b)	south-east side
	(i)	from its roundabout junction with New Road to a point 14 metres north-east of the north-eastern building boundary of No 1 Penhale Cottages
	(ii)	from a point 10 metres south-west of the south-western building boundary of No 4 Penhale Cottages to a point opposite a point 16 metres south-west of its junction with Narrow Lane
Narrow Lane (C0754)		both sides from its junction with B3275 from New Road to Penhale for a distance of 21 metres in a north-westerly direction


