

## **The County of Cornwall (Restormel) (Various Settlements) (Restrictions on Waiting) (Amendment) Order 2020**

Cornwall Council in exercise of its powers under Sections 1, 32 and 35 of (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. This Order shall come into force on the 20<sup>th</sup> day of April 2022 and may be cited as "The County of Cornwall (Restormel) (Various Settlements) (Restrictions on Waiting) (Amendment) Order 2020".

2. The County of Cornwall (Various Streets) (Disabled Persons Street Parking Place) Order 2009 shall have effect as though:

**The section related to Charlestown was deleted.**

3. The County of Cornwall (Mevagissey) (Various Streets) (On-Streets Parking Places and Restrictions on Waiting) (Consolidation) Order 2005 shall have effect as though:

**In the Third paragraph relating to No waiting at any time:**

In paragraph 1 relating to Beach Road sub-paragraph (b) which includes the words '...for a distance of 94 metres...' was deleted.

4. The County of Cornwall (Restormel) (Rural Settlements) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2010 shall have effect as though:

### **CHARLESTOWN**

**In the First Schedule relating to No waiting at any time:**

Paragraphs 1(a)(iv) and (b)(ii) & (iii) were deleted and replaced with the following:
