The County of Cornwall (Roche) (Various Streets) (Restrictions on Waiting) (Amendment) Order 2019

Cornwall Council in exercise of its powers under Section 1 (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

- 1. The Order shall come into force on the 31st day of March 2021 and may be cited as 'The County of Cornwall (Roche) (Various Streets) (Restrictions on Waiting) (Amendment) Order 2019'.
- 2. The County of Cornwall (Roche) (Various Streets) (Restrictions on Waiting) (Consolidation) Order 2005 shall have effect as though:

In the First Schedule relating to No waiting at any time:

The paragraph relating to the Unnamed Class III Road leading to Bugle was deleted and replaced with the following:

Road from Fore Street to Burney Farm (C0018)

- (a) north side
- between points 50 metres and 70 metres east of the west side of its junction with the western access to Roche Community Primary School
- (ii) between points 20 metres west and 67 metres east of its junction with St Michaels Way
- (b) south side
- (i) from a point opposite a point 20 metres west of its junction with St Michaels Way for a distance of 54 metres in an easterly direction
- (ii) between points opposite points 41 metres and 67 metres south-east of its junction with St Michaels Way

In paragraph 5 the following was inserted:

- 5. Victoria Road (B3274)
- (a) east side
- (v) between points 9 metres south and 14 metres north of its south-western junction with Victoria Business Park
- (d) south-east side
 between points 10 metres south-west and 15

- (ii) from a point opposite a point 5 metres south-west of its junction with the south-western access to M-Store Self Storage for a distance of 13 metres in a north-easterly direction

- (iii) from a point opposite a point 5 metres south-west of its junction with the north-eastern access to M-Store Self Storage for a distance of 14 metres in a north-easterly direction
- (e) south side
- (i) from a point 8 metres east of its junction with the access leading to Units 4a, 4b & 5 to the eastern boundary of Mid Cornwall Cars Ltd
- (ii) from its south-western junction with Victoria Road for a distance of 34 metres in an easterly direction
- (f) south-east side
- (i) between points 6 metres south-west and 6 metres north-east of its junction with the south-western access leading to Victoria Trading Estate
- (ii) between points 5 metres south-west and 6 metres north-east of its junction with the north-eastern access leading to Victoria Trading Estate
- (iii) between points 5 metres south-west and 5 metres north-east of its junction with the south-western access leading to M-Store Self Storage
- (iv) between points 5 metres south-west and 5 metres north-east of its junction with the north-eastern access leading to M-Store Self Storage
- (g) south-west side
- from its north-eastern junction with Victoria Road to a point 55 metres west of the eastern boundary of the Fish Processing Facility
- (ii) between points 36 metres and 67 metres northwest of its junction with the south-eastern access leading to Brake Bros
- (iii) between points 9 metres north-west and 14 metres south-east of its junction with the south-eastern access leading to Brake Bros
- (iv) between points 13 metres north-west and 15 metres south-east of its junction with the northeastern access leading to St Merryn Meat Ltd
