

**The County of Cornwall (Penwith) (Sennen Cove) (Restrictions on Waiting)
(Experimental) Order 2022**

Cornwall Council in exercise of its powers under Sections 9 and 10 of the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. This Order shall come into force on the 28th day of April 2022 for a period of 18 months and may be cited as "The County of Cornwall (West Penwith) (Cove Road) (Restrictions on Waiting) (Experimental) Order 2022".
2. In this Order:
 - (i) any reference to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated or re-enacted by or as having effect by virtue of any subsequent enactment.
 - (ii) "enactment" means any enactment whether public, general or local and includes any byelaw, rule, regulation, scheme, or other instrument having effect by virtue of enactment.
3. In so far as any provision of this Order conflicts with any provision of any Order previously made or having effect as if it were previously made under the Act of 1984 and which imposes a restriction or prohibition on vehicles or grants an exemption from such restriction or prohibition then that provision of this order shall prevail.
4. Except where provided by Article 3, the prohibitions and restriction imposed by this Order shall be in addition to and not in derogation of any other prohibition or restriction whether made under the Act of 1984 or otherwise.
5. The Head of Highways and infrastructure at Cornwall Council, or a person authorised by him, may modify or suspend the operation of this Order or any provision of it, if it appears to him essential:
 - (i) In the interests of the expeditious, convenient and safe movement of traffic;
 - (ii) In the interests of providing suitable and adequate on-street parking facilities; or
 - (iii) For preserving or improving the amenities of the area through which any road affected by the Order runs.
6. The County of Cornwall (Penwith) (Rural Settlements) (Various Streets) (On-street Parking Places and Restrictions on Waiting) (Consolidation) Order 2009 shall have effect as though:

In the part for Sennen, in the First Schedule relating to No waiting at any time:

Paragraph 2 was deleted.

The following new paragraphs were inserted:

Road from Upton Lodge
to Sennen Cove Lifeboat
Station
(C0094)

both sides
from its junction with Cove Road to its junction with
Access to Road Between Cove Hill and Pedn Men Du

Road from Upton Lodge
to Sennen Cove Lifeboat
Station (Turning space
between Shelbourne and
Aubrey Villa)
(Unadopted)

both sides
for its entire length

In the second Schedule relating to No waiting between 01 Mar and 30 Sep

Paragraphs 1 and 2 were deleted.
