The County of Cornwall (St Austell) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Amendment) (Part 2) Order 2021

THE CORNWALL COUNCIL in exercise of its powers under Sections 1, 32 and 35 of (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

In the Second Schedule relating to No waiting at any time:

In paragraph 21 the road classification reference was deleted and replaced with the reference '(U6109/U6111/Unadopted)'. Also, the following was inserted:

(ii) from a point 3 metres north-east of the northeastern boundary of No 172 Killyvarder Way to the north-eastern boundary of No 2 Gerrans Close
