

**The County of Cornwall (St Blazey, Par and Tywardreath) (Middleway)
(Restrictions on Waiting) (Amendment) Order 2021**

THE CORNWALL COUNCIL in exercise of its powers under Sections 1, 32 and 35 of (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. This Order shall come into force on the 26th day of April 2023 and may be cited as "The County of Cornwall (St Blazey, Par and Tywardreath) (Middleway) (Restrictions on Waiting) (Amendment) Order 2021".
2. The County of Cornwall (St. Blazey/Par and Tywardreath) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2005 shall have effect as though:

In the First Schedule relating to No waiting at any time:

In Paragraph 17 the following was inserted:
