The County of Cornwall (St Blazey, Par and Tywardreath) (Middleway) (Restrictions on Waiting) (Amendment) Order 2021

THE CORNWALL COUNCIL in exercise of its powers under Sections 1, 32 and 35 of (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

- 1. This Order shall come into force on the 26th day of April 2023 and may be cited as "The County of Cornwall (St Blazey, Par and Tywardreath) (Middleway) (Restrictions on Waiting) (Amendment) Order 2021".
- 2. The County of Cornwall (St.Blazey/Par and Tywardreath) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2005 shall have effect as though:

In the First Schedule relating to No waiting at any time:

In Paragraph 17 the following was inserted:

17. Middleway (U6142)

- (c) north-west side from a point 37 metres south-west of the southwestern boundary of No 4 Fountain Terrace to a point 15 metres south-west of the north-eastern boundary of No 19 Middleway
- (d) south-east side from a point 7 metres north-east of the southwestern boundary of Middleway Surgery to its junction with the access to Latham Park

In the Second Schedule relating to No waiting 8am-6pm daily:

Paragraph 5 was deleted and replaced with the following:

5. Middleway (U6142)

- (a) north-west side
- (i) from its junction with Station Road to a point 2 metres south-west of the north-eastern boundary of No 1 Fernlea Villas

- (ii) from a point 15 metres south-west of the northeastern boundary of No 19 to a point 8 metres east of the eastern boundary of No 13
- (b) south-east side
- (i) from its junction with St Blazey Road to a point 13 metres north-east of the south-western boundary of Middleway Surgery
- (ii) from its junction with the access to Latham Park to a point 4 metres west of the eastern boundary of No 4
