

The County of Cornwall (St Blazey, Par and Tywardreath) (On-Street Parking Places and Restrictions on Waiting) (Amendment) Order 2019

Cornwall Council in exercise of its powers under Sections 1, 32 and 35 of (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Order shall come into force on the 19th day of October 2020 and may be cited as "The County of Cornwall (St Blazey, Par and Tywardreath) (On-Street Parking Places and Restrictions on Waiting) (Amendment) Order 2019".
2. The County of Cornwall (St. Blazey/Par and Tywardreath) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2005 shall have effect as though:

In the opening paragraph of Article 3 the words 'parking places' were deleted and replaced with the words 'the parking places specified in Part II – Parking Places'.

Article 6.2 relating to the position of a vehicle within a parking place was deleted.

In Articles 6.9 and 6.10 the words 'traffic warden' were deleted and replaced with the words 'Civil Enforcement Officer'.

In the First Schedule relating to No waiting at any time:

The paragraph relating to Old Roselyon Road was deleted and replaced with the following:

 - (ii) from a point 8 metres north-east of the north-eastern boundary of No 159 to a point 11 metres west of the eastern boundary of No 181

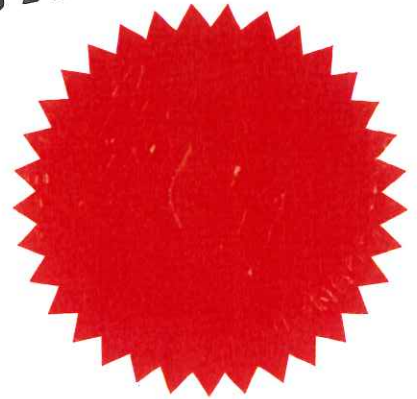
