# THE COUNTY OF CORNWALL (ST BLAZEY, PAR & TYWARDREATH) (VARIOUS STREETS) (RESTRICTIONS ON WAITING) (AMENDMENT) ORDER 2012

Cornwall Council in exercise of its powers under Sections 1, 2, 32 and 35 of (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

- 1. The Order shall come into force on the letter day of September 2013 and may be cited as "The County of Cornwall (St Blazey, Par & Tywardreath) (Various Streets) (Restrictions on Waiting) (Amendment) Order 2012".
- 2. The County of Cornwall (St Blazey/Par & Tywardreath) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2005 shall have effect as though:

The following was inserted after Article 3.2.4:

between the hours of 8am and 6pm in the length of road specified in the Eleventh Schedule to this Order:-

(i) for a longer period than 20 minutes; or (ii) if a period of less than 1 hour has elapsed since the termination during the said hours of the last period of waiting (if any) of the vehicle in that length of road.
