THE CORNWALL COUNCIL in exercise of its powers under Sections 1, 2, (and Part IV of Schedule 9) to the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

- 2. The County of Cornwall (St Columb Major) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) Consolidation) Order 2010 shall have effect as though:

After article 3.2.1 the following new article was inserted:

between the hours of 9am and 6pm Monday – Saturday (both days inclusive) in the lengths of road specified in the Third Schedule of this Order.

(i) for a longer period than 1 hour; or

(ii) if a period of less than 2 hours has elapsed since the termination during the said hours of the last period of waiting (if any) of the vehicle in that length of road.

In the First Schedule relating to No waiting at any time:

Paragraph 2 relating to Bridge Hill was hereby deleted and replaced with the following:
