The County of Cornwall (St Ives) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Amendment) (Part 1) Order 2018

Cornwall Council in exercise of its powers under Sections 1 and 2 of (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

- 1. The Order shall come into force on the 2 day of April 2019 and may be cited as "The County of Cornwall (St Ives) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Amendment) (Part 1) Order 2018".
- 2. The County of Cornwall (St Ives) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2009 shall have effect as though:

In the opening paragraph of Article 3 the words 'parking places' were deleted and replaced with the words 'the parking places specified in Part II – Parking Places'.

In Article 6.1(i) the word '7.2' was deleted and replaced with the word '6.2'.

Article 8.2 relating to the position of a vehicle within a parking place was deleted.

In Articles 8.8 and 8.9 the words 'traffic warden' were deleted and replaced with the words 'Civil Enforcement Officer'.

In the First Schedule relating to No waiting at any time:

Paragraph 13 was deleted and replaced with the following:

13. Bedford Road (U6013)

(a) north side

(i) from its junction with High Street for a distance of 31 metres in a westerly direction

(ii) from the western building boundary of United Methodist Community Church to a point 4 metres east of the western boundary of No 1

(iii) from the western boundary of No 5 to the eastern boundary of No 17

(iv) from the eastern boundary of No 27 to a point 1 metre west of the western boundary of No 35

(v) from the eastern boundary of No 43 to its junction with Drillfield Lane

(b) south side

- (i) from its junction with Tregenna Place to a point 10 metres south-west of its junction with Wesley Place (west)
- (ii) from its junction with Drillfield Lane for a distance of 7 metres in a north-easterly direction

Paragraph 114 was deleted and replaced with the following:

114. Windsor Hill (U6013)

- (a) north-east side between its junctions with Carrack Dhu Estate and Carrack Dhu
- (b) south-west side
- (i) from its junction with Carrack Dhu Estate to the north-western boundary of No 3 Belmont Place
- (ii) from the south-eastern boundary of No 8
 Belmont Place to its junction with the Access to rear of Windsor Terrace

In the Thirteenth Schedule relating to No loading at any time:

The following new paragraphs were inserted:

Bedford Road (U6013)

- (a) north side
- (i) from the eastern boundary of No 1 to a point 4 metres east of the western boundary of No 1
- (ii) from the western boundary of No 5 to the eastern boundary of No 17
- (iii) from the eastern boundary of No 27 to a point 1 metre west of the western boundary of No 35
- (iv) from the eastern boundary of No 43 to its junction with Windsor Hill
- (b) south side
- (i) form its junction with Wesley Place (west) for a distance of 10 metres in a south-westerly direction
- (ii) from its junction with Drillfield Lane for a distantion of 7 metres in a north-easterly direction
