

**The County of Cornwall (Cot Hill) (Stratton)
(Restrictions on Waiting) Amendment Order 2023**

THE CORNWALL COUNCIL in exercise of its powers under Sections 1, 32 and 35 of (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. This Order shall come into force on the 25th day of *October* 2023 and may be cited as "The County of Cornwall (Cot Hill) (Stratton) (Restrictions on Waiting) Amendment Order 2023".
2. The County of Cornwall (Stratton) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2005 shall have effect as though:

In the First Schedule relating to No waiting at any time:

Paragraph 2 relating to Church Square was deleted.

Paragraph 3(a) was deleted and replaced with the following:

Paragraph 11 was deleted and replaced with the following:

11. Maiden Street (C0309)
- (i) both sides
from its junction with Market Street (south) to the northern building boundary of No 27
 - (ii) from its junction with Market Street (north) to a point 8 metres south of its junction with Cot Hill

The following new paragraphs were inserted:

- Church Street (east spur) (a) north-east side
(U6189) from a point 6 metres south-east of a point opposite the north side of its junction with Church Street (west spur) to its junction with Cot Hill
- (b) south-west side
for its entire length

Church Street (west spur) both sides
(U6189) for its entire length

Market Street (north) both sides
(C0309) from its junction with Maiden Street to a point 9 metres north of its junction with Cot Hill

Market Street (south) both sides
(C0309) for its entire length


