THE CORNWALL COUNCIL in exercise of its powers under Sections 1, 32 and 35 of (and Part IV of Schedule 9 to) the Road Traffic Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

(ii) from its junction with Richmond Hill to a point 5 metres south-east of the north-western boundary of No 1a Harrison Terrace

In paragraph 67 the road number '(C0737)' was deleted and replaced with the words '(C0737/U6077)'. Also, the following was inserted:

67. George Street (C0737/U6077)

both sides

(ii) from a point 16 metres south-east of the northwestern boundary of No 17 Ferris Hill to its southern termination next to that property, including the turning head

The following new paragraph was inserted:

Gas Hill

both sides

(Unclassified/Unadopted)

for its entire length

In the Eighth Schedule relating to No waiting Mon-Sat 8am-6pm:

Paragraphs 23(a) and (b)(iii) were deleted and replaced with the following:

23. George Street (U6077)

(a) north-east side from a point 16 metres south-east of the northern boundary of No 17 Ferris Hill to its termination north-west of its junction with John Street

In the Twenty-Third Schedule relating to Limited waiting Mon-Sat 8am-6pm 2 hours no return within 4 hours:

The paragraph relating to Bosvigo Road was deleted and replaced with the following:

Bosvigo Road (U6077) south-west side from a point 5 metres south-east of the northwestern boundary of No 1a Harrison Terrace to a point 5 metres north-west of its junction with Harrison Terrace
