

## **The County of Cornwall (Truro) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Amendment) (Part 1) Order 2018**

Cornwall Council in exercise of its powers under Sections 1, 2, 32 and 35 of (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as 'the Act of 1984') and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Order shall come into force on the 29<sup>th</sup> day of April 2019 and may be cited as "The County of Cornwall (Truro) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Amendment) (Part 1) Order 2018".

2. The County of Cornwall (Truro) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2010 shall have effect as though:
