

**The County of Cornwall (Caradon) (Upton Cross) (Restrictions on Waiting)
(Amendment) Order 2019**

Cornwall Council in exercise of their powers under Section 1 (and Part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby make the following Order:-

1. This Order shall come into force on the 14th day of December 2020 and may be cited as "The County of Cornwall (Caradon) (Upton Cross) (Restrictions on Waiting) (Amendment) Order 2019".
2. The County of Cornwall (Caradon) (Rural Settlements) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2009 shall have effect as though:
