In the Second Schedule relating to No waiting at any time:

Paragraph 1 was deleted and replaced with the following:

 B3254 between Port Lane and Tremabe Lane (B3254) west side

from its junction with Class III road leading to Minions for a distance of 81 metres in a northwesterly direction

Paragraph 2 relating to Road from junction north of Cresta to junction south-west of Caradon View was deleted and replaced with the following:

 Class III road leading to Minions (C0037)

north side

- (i) from its junction with the B3254 between Port Lane and Tremabe Lane for a distance of 10 metres in a westerly direction
- (ii) between points 4 metres and 17 metres west of the western boundary of Upton Cross Primary School

3. The County of Cornwall (School Keep Clear Entrance Markings) (Prohibition of Stopping) Order 2017 shall have effect as though:

In the First Schedule relating to No stopping at any time on school keep clear markings:
