

The County of Cornwall (Wadebridge) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Amendment) Order 2021

Cornwall Council in exercise of its powers under Sections 1, 32 and 35 of (and part IV of Schedule 9 to) the Road Traffic Regulation Act 1984 (hereinafter referred to as “the Act of 1984”) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

1. This Order shall come into force on the 20th day of *June* 2022 and may be cited as “The County of Cornwall (Wadebridge) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Amendment) Order 2021”.
2. The County of Cornwall (Wadebridge) (Various Streets) (On-Street Parking Places and Restrictions on Waiting) (Consolidation) Order 2009 shall have effect as though:

After Article 2.1.14 the following new Article was inserted:

2.1.15 **“Police Parking Place”** means any area of highway described in the Sixteenth Schedule to this Order;

After Article 5.2 the following new Articles were inserted:

5A **Police Parking Places**

5A.1 The area of highway specified in the Sixteenth Schedule to this Order is authorised to be used, subject to the following provisions of this Order, as a parking place on such days and during such hours as are specified in relation to that area of highway in the said Schedule.

5A.2 No person shall leave any vehicle at any time in a Police Parking Place during the Permitted Hours unless that vehicle is an operational Police vehicle, or a vehicle authorised by the Police Authority to be used by civilian operators operating under the instructions of a Chief Officer of Police.

In Article 7.1 after the word ‘5’ the words ‘, 5A’ were inserted.

In the Third Schedule relating to No waiting at any time:
