ROAD TRAFFIC REGULATION ACT 1984 - SECTIONS 64 AND 65 AUTHORISATION OF TRAFFIC SIGNS AND SPECIAL DIRECTIONS

The Secretary of State for Transport, in exercise of his powers under Sections 64 and 65 of the Road Traffic Regulation Act 1984, and of all other powers enabling him in that behalf, for the purpose of informing road users of charging points for electric vehicles in Croft Road and Little Park Street, Coventry, hereby:-

- 1. authorises the erection at or within 5 metres of the sites marked with a red cross in the attached set of plans numbered GT46/2/194(Pt1)-5 of a traffic sign (hereinafter referred to as "the authorised sign") conforming as to size, colour and character with that shown on the attached drawing numbered GT46/2/194(Pt1)-6, save that the times of the day, the days of the week and the limits of waiting may be added or varied; and
- 2. authorises the placing within the vicinity of the sites highlighted in yellow of a traffic sign consisting of a road marking (hereinafter referred to as "the authorised marking") conforming as to size, colour and character with those shown in diagrams 1028.3 in Schedule 6 to the Traffic Signs Regulations 2002 (Part I of SI 2002/3113, "the 2002 Regulations"), save that the legend 'ELECTRIC VEHICLES ONLY' shall be added in the manner shown in diagram 1028.3 in those Regulations; and
- 3. directs that the authorised marking shall only be used in conjunction with the authorised sign; and



- 4. directs that it is a condition of this authorisation that the authorised sign and the authorised marking may be placed only to indicate the effect of a corresponding Traffic Regulation Order; and
- 5. directs that, without prejudice to any statutory provision to the like effect, that it is a condition of this authorisation that the erection of the authorised sign and placing of the authorised marking shall continue to have effect only until such day as may be appointed by one month's notice given by the Secretary of State in writing to the traffic authority for the removal or alteration of the authorised sign and the authorised marking and on that day the said authorisation shall, without prejudice to the giving of any further authorisation or direction, cease to have effect.

The provisions of Regulations 12, 18 and 19 of the 2002 Regulations shall apply to the authorised sign in the same manner as they apply to the sign shown in diagram 661.1 in Schedule 2 to those Regulations.

The provisions of Regulations 12 and 31 of the 2002 Regulations shall apply to the authorised marking in the same manner as they apply to the road marking shown in diagrams 1028.3 in Schedule 6 to those Regulations.






