THE COUNTY OF CUMBRIA (VARIOUS ROADS, CARLISLE URBAN AND RURAL AREA)(CONSOLIDATION AND MINOR AMENDMENT OF TRAFFIC REGULATIONS) (ORDER 2001) VARIATION ORDER (NO. 53) (ZONE D REVIEW AND NEW ZONE M – CARLISLE) 2018

The County Council of Cumbria in exercise of its powers under Sections 1(1), 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53 and 64 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- This Order shall come into operation on 31 May 2018 and may be cited as The County of Cumbria (Various Roads, Carlisle Urban and Rural Area) (Consolidation and Minor Amendment of Traffic Regulations) (Order 2001) Variation Order (No. 53) (Zone D Review and New Zone M) Order 2018
- For the purposes of this Order the expression "the 2001 Order" shall mean The County of Cumbria (Various Roads, Carlisle Urban and Rural Area) (Consolidation and Minor Amendment of Traffic Regulations) Order 2001
- 3. The 2001 Order shall have effect as though: -
 - (a) The heading to the whole of Schedule XXXIV was amended to read: -
 - "Designated Parking Places Zones A, B, C, D, E, F, G, H, J and M Carlisle"
 - (b) The heading to Part XV was amended to read: -
 - DESIGNATED PARKING PLACES ZONES A, B, C, D, E, F, G, H, J & M CARLISLE"
 - (c) The following was added as Article 42(ix): -
 - (ix) Residents of streets specified in Zone M of Schedule XXXIV to this Order will be exempt from the time limits in the parking places specified in Zone M of the said Schedule.
 - (d) Zone M to Schedule XXXIV attached was added as new Zone M to Schedule XXXIV thereto;

(e) Schedule XXXV was amended to read as follows: -

Zone F (Scotland Road) – Disc Parking Places between 8.00 am and 8.00 pm, Monday to Friday inclusive, 8.00 am – 6.00 pm on Saturdays – Waiting Limited to 20 minutes, return prohibited within 1 hour;

Zone G – Parking Places 24 hours a day, 7 days a week for Zone G Residents only;

Zone J – Disc Parking Places between 8.30 am – 6.00 pm, Monday to Saturday inclusive, waiting limited to 30 minutes, return prohibited within 1 hour.


