

**THE COUNTY OF CUMBRIA (VARIOUS ROADS, DISTRICT OF EDEN)**  
**(CONSOLIDATION AND PROVISION OF TRAFFIC REGULATIONS) (ORDER**  
**2018) VARIATION (NO.1) ORDER 2019**

The County Council of Cumbria (hereinafter referred to as “the Council”) in exercise of its powers under Sections 1(1), 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53 and 64 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (“the Act”) and Part 6 of the Traffic Management Act 2004 and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order shall come into operation on 1 April 2019 and may be cited as The County of Cumbria (Various Roads, District of Eden) (Consolidation and Provision of Traffic Regulations) (Order 2018) Variation (No. 1) Order 2019
2. For the purposes of this Order the expression “the 2018 Order” shall mean The County of Cumbria (Various Roads, District of Eden) (Consolidation and Provision of Traffic Regulations) Order 2018
3. The 2018 Order shall have effect as though

- (a) The following entry in Schedule 6 “Parking Places, 9 am – 5 pm, March to October inclusive, Waiting Limited to 2 hours, Return Prohibited within 2 hours”, was deleted: -

And replaced with the following: -

- (c) The following was added as Article 27(9)(B): -

27 (9)(B) between the hours of 9 am and 5 pm, on any day other than a Sunday, in the lengths of road or sides of road specified in **Schedule 8B** to this Order: -

- (a) For a longer period than 30 minutes, or
- (b) If a period of less than 2 hours have elapsed since the termination during the said half hour of the last period of waiting (if any) by that vehicle on the same side of road or length of road.

- (d) The following was added as Schedule 8B “ Parking Places, 9 am – 5 pm, Monday to Saturday inclusive, Waiting Limited to 30 minutes, Return Prohibited within 2 hours” : -

(e) Article 15 was amended to read: -

15. (1) When a vehicle has left a parking place specified in: -

- (a) Schedules 1, 2, 3, 4, 5, 6, 8 and 8B to this Order after waiting thereon, the driver thereof shall not within two hours after its leaving permit it to wait again upon that parking place;
- (b) Schedules 7 and 8A of this Order to this Order after waiting thereon, the driver thereof shall not within one hour after its leaving permit it to wait again upon that parking place.

(f) The following entries were added to Schedule 9 "No Waiting At Any Time": -

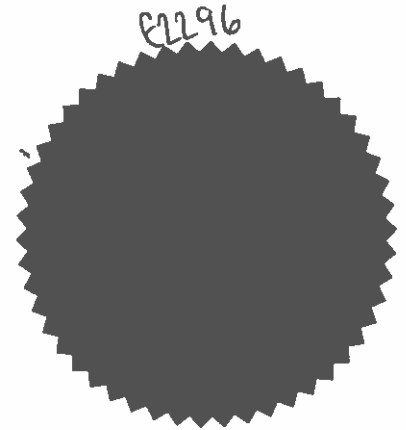
