THE COUNTY OF CUMBRIA (VARIOUS ROADS, GRANGE-OVER-SANDS) (CONSOLIDATION AND PROVISION OF TRAFFIC REGULATIONS) ORDER 2020

The County Council of Cumbria (hereinafter referred to as "the Council") in exercise of its powers under Sections 1(1), 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53 and 64 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

PART I

GENERAL

- 1. This Order shall come into operation on 24 February 2020 and may be cited as The County of Cumbria (Various Roads, Grange-over-Sands) (Consolidation and Provision of Traffic Regulations) Order 2020.
- 2. In this Order, except where the context otherwise requires, the following expressions have the meanings hereby respectively assigned to them:-
 - (1) "delivering" and or "collecting" in relation to any goods includes checking the goods for the purpose of their delivery or collection;
 - "disabled person" means a person who holds a disabled persons' badge in accordance with the provisions of the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000 (No. 682) (and in particular Regulation 4 thereof) or any reenactment thereto;
 - (3) "disabled person's badge" means a badge issued in accordance with the provisions of the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000 (as amended) (in particular Regulation 11 and the Schedule thereto) or under regulations having effect in Scotland and Wales under Section 21 of the Chronically Sick and Disabled Persons Act 1970 as referred to currently by the Local Authorities Traffic Orders (Exemptions for Disabled) (England) Regulations 2000 (No. 683) or any subsequent further re-enactments thereof;
 - (4) "disabled person's vehicle" means a vehicle driven by a disabled person as defined in Regulation 4(2) of the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000 (No. 682);
 - (5) "driver", in relation to a vehicle waiting in a parking place, means the person driving the vehicle at the time it was left in the parking place (and shall, as appropriate, bear the meaning assigned by Section 142 of the 1984 Act);

- (6) "goods" shall mean material possessions, goods, burdens and items of any description and shall include cash or other valuable securities and be of such weight or bulk that they cannot be reasonably conveyed otherwise than by means of a vehicle;
- (7) "goods vehicle" means for the purpose of this Order a motor vehicle which is constructed or adapted for the carriage of goods or burden of any description, the unladen weight of which does not exceed 1.524 tonnes;
- (8) "junction" means, unless otherwise indicated in this Order, the intersection of the general alignment of the carriageway kerbline boundaries of two roads;
- (9) "loading/unloading" means when a vehicle stops to load or unload bulky or heavy goods;
- (10) "local authority" means, for the purposes of this Order, a County Council or District Council;
- (11) "motor car" shall mean and include any mechanically propelled vehicle not being a motor cycle or an invalid carriage, which is constructed itself to carry passengers of which the weight unladen does not normally exceed 3050 kilograms subject always to the inclusion of the extended meaning to this term given in Section 136 of the 1984 Act (and whether or not it is being used for business purposes);
- "motor cycle" and "invalid carriage" have the same meanings respectively as in Section 136 of the Act;
- (13) "motor vehicle" means any class of mechanically propelled vehicle including motor cycles motor cars goods vehicles and car derived vans, and shall bear the extended definition given thereto in Sections 136 and 137 of the 1984 Act (but shall not include any commercial vehicle as defined above or any heavy commercial vehicle as defined in Section 138 of the Act) (and whether or not it is being used for business purposes). Where reference is made to vehicle or motor vehicle in the Order these terms shall be deemed to have the same meaning and be interchangeable and to be interpreted accordingly;
- (14) "owner" in relation to a vehicle means the person by whom such vehicle is kept and used:
- "parking attendant" shall mean the person or persons duly authorised in writing in that behalf (from time to time) by the Council;
- (16) "parking device" shall have the meaning assigned to it in the 1984 Act (Section 142; Section 35(3B); Section 51(4) and shall include parking disc;
- (17) "parking disc" in relation to Part IV of this Order (Disabled Persons Parking Places), a device which:-
 - (i) is 123 millimetres square and coloured blue, issued on or after 1st April 2000, or orange if issued before that date;

- (ii) has been issued by a local authority and has not ceased to be valid;
- (iii) is capable of showing the quarter hour period during which a period of waiting began;
- (18) "parking place" means any part of a road authorised by this Order to be used as a parking place;
- (19) "passenger vehicle" means a motor vehicle (other than a motor cycle, an invalid carriage, goods vehicle or heavy commercial vehicle) as defined in this Order;
- (20) "post office" and any reference to "post office vehicle" or "postal packets" shall be construed in the context of the Postal Services Act 2000 and the Consequential Amendments Order 2001 (No. 2001/648) and shall include therefore references to "universal service providers" such as Consignia Plc, as the context shall require;
- (21) "quarter hour period" means:in relation to Part IV of this Order a period of quarter of an hour starting at any hour or fifteen, thirty or forty-five minutes past the hour which can be shown on the parking disc;
- (22) "registered keeper" means:-
 - (a) the person whose name appears in the vehicle registration document or book of the vehicle in whose name the vehicle is registered, or
 - (b) a person who has the permanent use of the vehicle vested in the name of his employer, or in the case of a leased vehicle in the name of the leasing company;
- (23) "relevant position" means (in conformity with Regulation 12 of SI 2000 No. 682) referred to above):-
 - (a) in relation to a disabled person's badge,
 - (i) in the case of a vehicle fitted with a dashboard or facia panel, the badge is exhibited thereon so that Part 1 of the badge is legible from outside the vehicle; or
 - (ii) in the case of a vehicle not fitted with a dashboard or facia panel, the badge is exhibited in a conspicuous position on the vehicle so that Part 1 of the badge is legible from outside the vehicle
- (24) "road" means the full width of the highway including the carriageway and footway;
- (25) "traffic sign" means a sign or marking of any size colour and type prescribed or authorised under, or having effect as though prescribed or authorised under, Section 64 of the 1984 Act;
- (26) "trailer" shall have the meaning assigned to it by Section 138(3) of the 1984 Act;

- (27) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
- (28) The Interpretation Act 1978 and any statutory modification or reenactment thereof brought into effect after the date of this Order shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament and as if this Order were an Act of Parliament for the purposes of Section 22 of the Interpretation Act 1978.
- 3. The restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any Regulations made or having effect as if made under the Act of 1984, The Road Traffic Act 1991, or by or under any other enactment.

PART II

PROHIBITION AND RESTRICTION OF WAITING

Restriction of Waiting

- 4. (A) Save as provided in Article 5, no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a parking attendant, cause or permit any vehicle to wait between the hours of 9.00 am and 6.00 pm each day, in any parking place specified in Schedule 1 of this Order: -
 - (1) for a longer period than 1 hour; or
 - (2) if a period of less than 1 hour has elapsed since the termination during the said hour of the last period of waiting (if any) by that vehicle on the same length of road.
 - (B) Save as provided in Article 5, no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a parking attendant, cause or permit any vehicle to wait between the hours of 9.00 am and 6.00 pm On a Monday to Saturday inclusive, in any parking place specified in Schedule 2 of this Order: -
 - (1) for a longer period than 1 hour; or
 - (2) if a period of less than 1 hour has elapsed since the termination during the said hour of the last period of waiting (if any) by that vehicle on the same length of road.

Exemptions

5. (1) Nothing in Article 5 of this Order shall render it unlawful to cause or permit any vehicle to wait in the lengths of road or sides of road referred to therein if the vehicle is:-

- (a) waiting only so long as is necessary to enable a person to board or alight from the vehicle or to enable goods or merchandise to be loaded onto or unloaded from the vehicle:
- (b) waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary in order to avoid accidents;
- (c) a vehicle used for police, fire brigade or ambulance purposes, or a vehicle (other than a passenger vehicle) in the service of a local authority or water authority which is being used in pursuance of statutory powers or duties;
- (d) waiting to enable it to be used in connection with the removal of any obstruction to traffic;
- (e) being used by statutory undertakers or their contractors in connection with the laying erection alteration or repair in or in land adjacent to that length of road of any sewer or of any main pipe or apparatus for the supply of water gas or electricity or of any telecommunications apparatus as defined in Schedule 2 of the Telecommunications Act 1984.
- (2) A disabled person's vehicle which displays in the relevant position a disabled person's badge shall be exempt from compliance with any limitation of time during which a vehicle may be left in the lengths of road or sides of road specified in Article 4 to this Order.

Prohibition of Waiting

- 6. Save as provided in Article 7 of this Order, no person shall except upon the direction or with the permission of a police constable in uniform, or of a parking attendant, cause or permit any vehicle to wait:-
 - (1) at any time in the lengths of road or the sides of road specified in Schedule 3 of this Order;
 - (2) between the hours of 8.00 am and 6.00 pm on any day, in the lengths of road or sides of road specified in Schedule 4 to this Order;
 - (3) between the hours of 9.00 am and 4.00 pm on any day, in the lengths of road or sides of road specified in Schedule 5 to this Order;
 - (4) between the hours of 9.00 am and 6.00 pm on any day, in the lengths of road or sides of road specified in Schedule 6 to this Order.

Exemptions

7. Nothing in Article 6 of this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge and a parking disc (on which the driver or other person in charge of the vehicle has marked the time at which the period of waiting began) to wait in the lengths of road or on the sides of road referred to in the said Articles for a period not exceeding three hours (not being a

period separated by an interval of less than one hour from the previous period of waiting by the same vehicle in the same length of road or on the same side of road on the same day).

Provided that this paragraph shall not apply to such lengths or sides of road specified in the said Schedules during such times as loading and unloading restrictions are in force.

- 8. Nothing in Article 6 shall render it unlawful for a person to cause or permit a vehicle to wait in the lengths or road or sides of road specified therein if the vehicle is:-
 - (a) waiting only so long as is necessary to enable a person to board or alight from the vehicle or to enable goods or merchandise to be loaded onto or unloaded from the vehicle;
 - (b) waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary in order to avoid accidents;
 - (c) a vehicle used for police, fire brigade or ambulance purposes, or a vehicle (other than a passenger vehicle) in the service of a local authority or water authority which is being used in pursuance of statutory powers or duties;
 - (d) waiting to enable it to be used in connection with the removal of any obstruction to traffic;
 - (e) in the service of or employed by the post office and is waiting while postal packets addressed to premises adjacent to the parking place in which the vehicle is waiting are being unloaded therefrom, or are being delivered or while postal packets are being collected from the premises or posting boxes adjacent to the parking place in which the vehicle is waiting, or, is in use in connection with the serving of posting boxes adjacent to the parking place in which the vehicle is waiting;
 - (f) being used in connection with any building operation or demolition the maintenance, improvement or reconstruction of the parking place or the laying, erection, alteration or repair in or near the said parking place of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in Schedule 2 to the Telecommunications Act 1984;
 - (g) in actual use in connection with the removal of furniture from one office or dwelling house to another or the removal of furniture from such premises to a depository or to such premises from depository;
 - (h) in actual use in connection with the removal of a coffin containing the remains of a deceased person to or from premises situated on or adjacent to that parking place.
- 9. Nothing in the foregoing provisions of this Order shall apply at a bus stop to a public service vehicle providing a local service, as defined in Section 2 of the Transport Act 1985, provided that the Highway Authority or its agent has agreed in writing that the bus stop is a suitable place at which such vehicles may wait for no longer than is necessary to take up or set down passengers.

PART III

PROHIBITION OF WAITING (EXCEPT FOR POLICE VEHICLES)

10. Save as provided in Article 11 of this Order, no person shall except upon the direction or with the permission of a police constable in uniform, or of a parking attendant, cause or permit any vehicle, other than a vehicle being used for police purposes, to wait at any time in the lengths of road specified in Schedule 7 to this Order.

Exemptions

- 11. Nothing in Article 10 of this Order shall render it unlawful for a person to cause or permit a vehicle to wait in the lengths or road or sides of road specified therein if the vehicle is:-
 - (a) waiting only so long as is necessary to enable a person to board or alight from the vehicle or to enable goods or merchandise to be loaded onto or unloaded from the vehicle;
 - (b) waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary in order to avoid accidents;
 - (c) a vehicle used for police, fire brigade or ambulance purposes, or a vehicle (other than a passenger vehicle) in the service of a local authority or water authority which is being used in pursuance of statutory powers or duties;
 - (d) waiting to enable it to be used in connection with the removal of any obstruction to traffic;
 - (e) in the service of or employed by the post office and is waiting while postal packets addressed to premises adjacent to the parking place in which the vehicle is waiting are being unloaded therefrom, or are being delivered or while postal packets are being collected from the premises or posting boxes adjacent to the parking place in which the vehicle is waiting, or, is in use in connection with the serving of posting boxes adjacent to the parking place in which the vehicle is waiting;
 - (f) being used in connection with any building operation or demolition the maintenance, improvement or reconstruction of the parking place or the laying, erection, alteration or repair in or near the said parking place of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in Schedule 2 to the Telecommunications Act 1984;
 - (g) in actual use in connection with the removal of furniture from one office or dwelling house to another or the removal of furniture from such premises to a depository or to such premises from depository;
 - (h) in actual use in connection with the removal of a coffin containing the remains of a deceased person to or from premises situated on or adjacent to that parking place.
- 12. A disabled person's vehicle which displays in the relevant position a disabled person's badge shall be exempt from complying with any limitation of time during which a vehicle may be left in the lengths of road or sides of road specified in Article 10 to this Order.

PART IV

DISABLED PERSON'S PARKING PLACE

Authorisation and Use of Disabled Person's Parking Place

- 13. Those parts of road specified in Schedule 8 to this Order are authorised to be used, at any time, on any day, subject to Articles 14 and 15 of this Order as a parking place for a valid disabled person's vehicle which displays a disabled person's badge and a parking disc in a relevant position for a period not three hours, providing that, where a vehicle has left a parking place specified in Schedule 8 of this Order after waiting thereon the driver thereof shall not within three hour after its leaving permit it to wait again upon that parking place.
- 13A. Those parts of road specified in Schedule 8A to this Order are authorised to be used, between the hours of 10 am and 5 pm each day, subject to Articles 14 and 15 of this Order as a parking place for a valid disabled person's vehicle which displays a disabled person's badge and a parking disc in a relevant position for a period not three hours, providing that, where a vehicle has left a parking place specified in Schedule 8A of this Order after waiting thereon the driver thereof shall not within three hour after its leaving permit it to wait again upon that parking place.
- 14. (1) For the avoidance of doubt, the driver of a vehicle shall not permit it to wait in the parking place specified in Schedules 8 and 8A to this Order unless the vehicle is
 - (a) a disabled person's vehicle which displays a disabled persons badge in a relevant position;
 - (b) is wholly within the limits of the parking place as indicated by the markings on the carriageway.
 - (2) The driver of a vehicle shall not use such a parking place
 - (a) so as to unreasonably prevent access to any premises adjoining the road, or the use of the road by other persons, or so as to be a nuisance
 - (b) when closed under the provisions of Article 15(1) of this Order.
 - (3) The driver of a motor vehicle using a parking place shall stop the engine as soon as the vehicle is in position in the parking place and shall not start the engine except when about to change the position of the vehicle in or to depart from the parking place.
 - (4) No person shall use a vehicle while it is in a parking place, in connection with the sale of any article to persons in or near the parking place or in connection with the selling or offering for hire of his skill or services.
 - (5) On the arrival of the vehicle at a parking place specified in Schedule 6 to this Order, during the period of waiting, exhibit on the vehicle in accordance with the following provisions of this Article a parking disc

- (6) The parking disc shall be exhibited in the relevant position on the vehicle
- (7) A parking disc while exhibited on the vehicle shall be so placed that the time of arrival, indicated to the nearest quarter hour period, shown on the front of the said disc is clearly visible to a person standing on the nearside of the vehicle.
- (8) When a parking disc has been displayed in a vehicle in accordance with the provisions of this Article, no person shall remove the parking disc from the vehicle unless authorised to do so by the driver of the vehicle.

Exemptions

- 15. (1) Nothing in Article 13 of this Order shall restrict the power of the Council or of the District Council for preventing obstruction of the street by Order on the occasion of any public procession rejoicing or illumination or where the street is thronged or liable to be obstructed to close the parking places specified in this Part of this Order.
 - (2) Nothing in Article 13 of this order shall render it unlawful for a vehicle to wait on the lengths of road or sides of road specified therein:-
 - (a) if it is being used for Police, Fire Brigade or Ambulance purposes;
 - (b) if its being used by statutory undertakers or their contractors in connection with any building operation or demolition, the maintenance, improvement or construction of the parking place or the laying, erection, alteration or repair in or near the parking place of any sewer or of any main pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in Schedule 2 to the Telecommunications Act 1984.
 - (c) waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary in order to avoid accidents;
 - (d) if its is being used in the service of a local authority or water authority which is being used in pursuance of statutory powers or duties;
 - (e) waiting to enable it to be used in connection with the removal of any obstruction to traffic;
 - (f) if goods are being sold or offered or exposed for sale from a vehicle by a person who is licensed by a local authority to sell goods from a stationary vehicle on a pitch situated in a parking place.

PART V

LOADING ONLY PARKING PLACES

16. Save as provided in Article 17 to this Order, no person shall cause or permit any vehicle to wait between the hours of 7.00 am and 9.00 am on any day, in the lengths of road or sides of

- road specified in Schedule 9 to this Order UNLESS the vehicle is waiting for the purpose of loading or unloading.
- 16A. Save as provided in Article 17 to this Order, no person shall cause or permit any vehicle to wait between the hours of 7.00 am and 10.00 am on any day, in the lengths of road or sides of road specified in Schedule 9A to this Order UNLESS the vehicle is waiting for the purpose of loading or unloading.

Exemptions

- 17. Nothing in Article 16 of this Order shall apply so as to render it unlawful for a person to cause or permit a vehicle to wait in the lengths of road specified therein if the vehicle is:-
 - (a) being used by statutory undertakers or their contractors in connection with any building operation or demolition the maintenance, improvement or reconstruction of the parking place or the laying, erection, alteration or repair in or near the said parking place of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in Schedule 2 to the Telecommunications Act 1984;
 - (b) waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary in order to avoid accidents;
 - (c) being used for police, fire brigade or ambulance purposes, or a vehicle (other than a passenger vehicle) in the service of a local authority or water authority which is being used in pursuance of statutory powers or duties.

PART VI

NO LOADING AT ANY TIME

18. Save as provided in Articles 19 and 20 to this Order, no person shall cause or permit any vehicle to wait at any time in the lengths of road or sides of road specified in Schedule 10 to this Order for the purpose of loading or unloading.

Exemptions

- 19. Nothing in Article 18 to this Order shall apply so as to render it unlawful for a person to cause or permit a vehicle to wait in the lengths of road specified therein if the vehicle is:-
 - (a) being used by statutory undertakers or their contractors in connection with any building operation or demolition the maintenance, improvement or reconstruction of the parking place or the laying, erection, alteration or repair in or near the said parking place of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in Schedule 2 to the Telecommunications Act 1984;
 - (b) waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary in order to avoid accidents;

- (c) being used for police, fire brigade or ambulance purposes, or a vehicle (other than a passenger vehicle) in the service of a local authority or water authority which is being used in pursuance of statutory powers or duties;
- (d)) if the vehicle is in actual use in connection with the removal of furniture from one office or dwelling house to another or the removal of furniture from such premises to a depository or to such premises from a depository; or
- (e) if the vehicle is being used for other exceptional loading or unloading purposes.
- 20. In accordance with Regulation 3 of The Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England and Wales) Regulations 2000 (SI No. 683), the restrictions specified in Article 18 of this Order shall not apply to a goods vehicle which displays in the relevant position a disabled person's badge.

PART VII

ONE-WAY TRAFFIC RESTRICTIONS

21. No person shall cause or permit any vehicle to proceed along the lengths of road or sides of road specified in Schedule 11 to this Order, other than in the directions specified therein.

PART VIII

PROHIBITION OF MOTOR VEHICLES (EXCEPT FOR ACCESS)

22. Save as provided in Article 23 of this Order, no person shall cause any motor vehicle to proceed along the roads or lengths of road specified in Schedule 12 of this Order.

Exemptions

- 23. Nothing in Article 22 of this Order shall apply so as to prevent any person from causing any motor vehicle to proceed along the road or lengths of road specified therein if the vehicle is being used:-
 - (i) for the conveyance of persons, goods or merchandise to or from any premises situated on or adjacent to that length of road; or
 - (b) in connection with any building operation or demolition in or adjacent to that length of road, the removal of any obstruction to traffic in that length of road, the maintenance, improvement or reconstruction of that length of road, or the laying, erection, alteration or repair in or adjacent to that length of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or any telegraphic lines or traffic sign; or
 - (c) any emergency being dealt with by the Police, Fire or Ambulance Service; or

- (d) being used for or in connection with mechanical road cleansing or mechanical refuse collection;
- (e) being used in connection with the removal of a coffin containing the remains of a deceased person to or from premises situated on or adjacent to the that length of road; or
- (f) being used in actual use in connection with the removal of furniture from one dwelling house to another or the removal of furniture from such premises to a depository or to such premises from the depository; or
- (g) taxis/hackney carriages operating at all times.

PART VIII

AMENDMENT/REVOCATION OF EXISTING ORDERS

17. The Orders specified in Schedule 13 to this Order are hereby revoked to the extent specified therein and to the extent that the provisions of this Order are inconsistent with, or incompatible with, the provisions of any other Order, Byelaws or enactment relating to traffic regulation in Grange-over-Sands in the South Lakeland area of Cumbria not specifically referred to in the said Schedule, the provisions of this Order shall prevail for all purposes.

PART IX

OPERATION OF THE ORDER

- 18. Nothing in the foregoing provisions of this Order shall be taken as authorising anything which would be a contravention of any Regulations made or to be made (or having effect as if made) under the Act.
- 19.
