

THE COUNTY OF CUMBRIA (VARIOUS ROADS, GRASMERE)
(CONSOLIDATION AND PROVISION OF TRAFFIC REGULATIONS) (ORDER 2018)
VARIATION (NO.1) 2018

The County Council of Cumbria in exercise of its powers under Sections 1(1), 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53 and 64 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order shall come into operation on 4 March 2019 and may be cited as The County of Cumbria (Various Roads, Grasmere) (Consolidation and Provision of Traffic Regulations) (Order 2018) Variation Order (No.1) 2019
2. For the purposes of this Order the expression “the 2018 Order;” shall mean The County of Cumbria (Various Roads, Grasmere) (Consolidation and Provision of Traffic Regulations) Order 2018.
3. The 2018 Order shall have effect as though:-

(a) The following entries were added to Schedule 4 “No Waiting 9 am – 6 pm”:-

<u>Street Number</u>	<u>Street Name</u>	<u>Side</u>	<u>Restricted Length</u>
B5287	Red Lion Square/ Church Stile	East	From the centre of its junction with Langdale Road/Broadgate extending in an easterly direction to a point 55 metres south of the centre of its junction with College Street.

(b) The following entry in Schedule 1 “Parking Places 9 am – 6 pm, Waiting Limited to 1 Hour, No Return within 1 Hour” was deleted in its entirety: -

<u>Street Number</u>	<u>Street Name</u>	<u>Side</u>	<u>Exemption</u>	<u>Restricted Length</u>
B4287	Red Lion Square	East		From a point 35 metres south east of the centre of its junction with Langdale Road in a south-easterly direction for a distance of 10 metres, to the southern boundary of the Post Office.

(c) The following entries in Schedule 4 "No Waiting 9 am – 6 pm", were deleted in their entirety: -

<u>Street Number</u>	<u>Street Name</u>	<u>Side</u>	<u>Restricted Length</u>
B5287	Broadgate/ Red Lion Square	Northeast	From the centre of its junction with Langdale Road/Broadgate in a south-easterly direction for a distance of 35 metres.
B5287	Church Stile/ Red Lion Square	East	From a point 45 metres south east of the centre of its junction with Langdale Road in a south-easterly direction to a point 55 metres south of the centre of its junction with College Street.

4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
