

THE COUNTY OF CUMBRIA (VARIOUS ROADS, SOUTH LAKELAND AREA)
(CONSOLIDATION OF TRAFFIC REGULATIONS) (ORDER 2002) (TOWN VIEW,
WEBB VIEW, EARLE COURT, CASTLE DRIVE, CASTLE GROVE AND PARKSIDE
ROAD, KENDAL) VARIATION ORDER 2020

The County Council of Cumbria in exercise of its powers under Sections 1(1), 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53 and 64 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order shall come into operation on 24 February 2020 and may be cited as The County of Cumbria (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) (Order 2002) (Town View, Webb View, Earle Court, Castle Drive, Castle Grove and Parkside Road, Kendal) Variation Order 2020
2. For the purposes of this Order the expression “the 2002 Order” shall mean The County of Cumbria (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) Order 2002
3. The 2002 Order shall have effect as though the following entries were added to “Schedule 52, Part 1, Kendal – No Waiting At any Time”: -

STREET NUMBER	STREET NAME	SIDE	RESTRICTED LENGTH
	Town View	East	From its junction with Windermere Road in a southerly direction for a distance of 64 metres
	Town View	West	From its junction with Windermere Road in a southerly direction for a distance of 57 metres
U5950	Webb View	Both	From the centre of its junction with Burneside road in a south easterly direction for a distance of 9 metres.
U5951	Earle Court	East	From its junction with Webb View in a north easterly direction for a distance of 45.2 metres.
U695	Castle Drive	Both	From the centre of its junction with Parkside Road in a northerly direction for a distance of 22 metres
U703	Castle Grove	Both	From the centre of its junction with Parkside Road in a northerly direction for a distance of 16.4 metres
U831	Parkside Road	North	From a point 26 metres west of the centre of its junction with Castle Drive to a point 22 metres east of the centre of its junctions with Castle Drive

U831	Parkside Road	North	From a point 25 metres west of the centre of its junction with Castle Grove to a point 17 metres east of the centre of its junctions with Castle Grove
