

THE COUNTY OF CUMBRIA (VARIOUS ROADS, SOUTH LAKELAND AREA)
(CONSOLIDATION OF TRAFFIC REGULATIONS) (ORDER 2002)
VARIATION ORDER (HEVERSHAM) 2019

The County Council of Cumbria in exercise of its powers under Sections 1(1), 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53 and 64 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order shall come into operation on 6 May 2019 and may be cited as The County of Cumbria (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) (Order 2002) Variation Order (Heversham) 2019
2. For the purposes of this Order the expression “the 2002 Order” shall mean The County of Cumbria (Various Roads, South Lakeland Area) (Consolidation of Traffic Regulations) Order 2002
3. The 2002 Order shall have effect as though: -
 - (a) The following entry in “Schedule 52, Part 5, Miscellaneous - No Waiting At Any Time”, was deleted: -

Heversham		NWAAT	East	From a point 102 metres north of the centre of its junction with the C5073 (Woodhouse Lane) for a distance of 152 metres in a southerly direction.

- (b) The following entries were added to “Schedule 52, Part 5, Miscellaneous - No Waiting At Any Time”: -

Heversham	C5072 (THE FORMER A6) LEASGILL	NWAAT	East	From a point 50 metres south of the centre of its junction with the C5073 (Woodhouse Lane) for a distance of 178 metres in a northerly direction
Heversham	C5072 (THE FORMER A6) LEASGILL	NWAAT	East	From a point 170 metres north of the centre of its junction with the C5073 (Woodhouse Lane) for a distance of 70 metres in a northerly direction

Heversham	C5072 (THE FORMER A6) LEASGILL	NWAAT	West	From a point 17 metres north of the centre of its junction with Heversham Gardens for a distance of 31 metres in a southerly direction
Heversham	C5072 (THE FORMER A6) LEASGILL	NWAAT	West	From a point 26 metres south of the centre of its junction with Heversham Gardens for a distance of 22 metres in a southerly direction

4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
