

THE COUNTY OF CUMBRIA (VARIOUS ROADS, WHITEHAVEN) (CONSOLIDATION OF TRAFFIC REGULATIONS) (ORDER 2009) VARIATION ORDER (NO. 1) 2011

The County Council of Cumbria in exercise of its powers under Sections 1(1), 2(1) to (3), 4(2) and (3), 32, 35, 45, 46, 47, 49, 53, 63A and 64 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order: -

1. This Order shall come into operation on 25 April 2011 and may be cited as The County of Cumbria (Various Roads, Whitehaven) (Consolidation of Traffic Regulations) (Order 2009) Variation Order (No.1) 2011
2. For the purposes of this Order the expression “the 2009 Order” shall mean The County of Cumbria (Various Roads, Whitehaven) (Consolidation of Traffic Regulations) Order 2009.
3. The 2009 Order shall have effect as though: -

(a) The following were added to Schedule 2 “No Waiting At Any Time”:-

<u>Town/Village</u>	<u>Street Name/ Number</u>	<u>Side(s)</u>	<u>Restricted Length</u>
Whitehaven	Catherine Mews (U4516)	All sides	From its western-most junction with the U4323 Catherine Street extending in a southerly, then generally easterly then northerly direction to its eastern-most junction with the U4323 Catherine Street, ie. its full length.

(b) Article 22(2) was amended to read as follows: -

22(2) No person shall cause or permit any vehicle, other than a bus, to wait between the hours of 8.30 am and 6.00 pm, on any day, in the lengths of road or sides of road specified in **Schedule 26** to this Order for longer than 1 hour providing also that the same vehicle shall not wait again in the same length or road or on the same side of road unless a period of one hour has elapsed since the termination of the last period of waiting.

(c) The heading to Schedule 26 was amended to read as follows:-

Schedule 26

**No Waiting Except for Buses between 8.30 am and 6.00 pm on any day,
Waiting Limited to 1 Hour, Return Prohibited within 1 Hour**

(d) The following entry in Schedule 27 “One-Way Traffic”, was deleted: -

<u>Town/Village</u>	<u>Street Name/ Number</u>	<u>Restricted Length</u>	<u>Direction of Travel</u>
Whitehaven	Chapel Street	From its junction with Roper Street to its junction with Lowther Street	From south west to north west

and replaced with the following: -

<u>Town/Village</u>	<u>Street Name/ Number</u>	<u>Restricted Length</u>	<u>Direction of Travel</u>
Whitehaven	Chapel Street	From its junction with Roper Street to its junction with Lowther Street	From south west to north east

(e) Article 40(3) was amended to read as follows: -

40(3) Save as provided in Article 41(6) of this Order, no person shall cause or permit a motor vehicle to proceed, at any time, on any day, in the lengths of road specified in **Schedule 32** to this Order.

(f) Article 40(4) was amended to read as follows: -

40(4) Save as provided in Article 41(7) of this Order, no person shall cause or permit any motor vehicle to proceed, at any time, on any day, in the lengths of road specified in **Schedule 33** to this Order.

(g) Article 73 was amended to read as follows: -

73. Save as provided in Article 74, no person shall cause or permit any vehicle stop between the hours of 8.00 am and 9.00 am or between the hours of 3.00 pm and 4.00pm, Monday to Friday inclusive, in the lengths of road or sides of road specified in **Schedule 46** to this Order.

(h) The heading to Schedule 46 was amended to read as follows: -

Schedule 46

Urban Clearway – No Stopping between 8.00 am and 9.00 am and between 3.00 pm and 4.00 pm, Monday to Friday inclusive.

4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
