

THE COUNTY OF CUMBRIA (VARIOUS ROADS, WHITEHAVEN)
(CONSOLIDATION OF TRAFFIC REGULATIONS) (ORDER 2009)
VARIATION ORDER (NO. 3) 2012

The County Council of Cumbria in exercise of its powers under Sections 1(1), 2(1) to (3), 4(2) and (3), 32, 35, 45, 46, 47, 49, 53, 63A and 64 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order: -

1. This Order shall come into operation on 27 August 2012 and may be cited as The County of Cumbria (Various Roads, Whitehaven) (Consolidation of Traffic Regulations) (Order 2009) Variation Order (No.3) 2012
2. For the purposes of this Order the expression “the 2009 Order” shall mean The County of Cumbria (Various Roads, Whitehaven) (Consolidation of Traffic Regulations) Order 2009.
3. The 2009 Order shall have effect as though: -

(a) The following entries were added to Schedule 2 “No Waiting At Any Time”: -

<u>Town/Village</u>	<u>Street Name/ Number</u>	<u>Side</u>	<u>Restricted Length</u>
Whitehaven	Station Road	East	From its junction with Calder Avenue to a point 129m south of its junction with Calder Avenue
Whitehaven	Coach Road	North- West	From its junction with the entrance to Marchon Club to a point 8m south west of its junction with the entrance to Marchon Club
Whitehaven	Meadow Road Mirehouse	South- West	From its junction with Whinlatter Road to a point approximately 37m south-east of its junction with Whinlatter Road
Whitehaven	Meadow Road Mirehouse	South- East	From a point approximately 63m south-west of its junction with Honister Road to a point 16m south-west to its junction with Whinlatter Road
Whitehaven	Meadow Road Mirehouse	North East	From its junction with Whinlatter Road to a point 21m south-east of its junction with Whinlatter Road (terminating at the entrance to a private lane).

(b) The following entry in Schedule 42 “No Stopping on School Entrance Markings (At time indicated on signs on site), was deleted

<u>Town/Village</u>	<u>Street Name/ Number</u>	<u>Restricted Length</u>
Whitehaven	Whinlatter Road Mirehouse	From a point 3m south of its junction with Herdus Road to a point 88m north of that junction

and replaced with the following: -

<u>Town/Village</u>	<u>Street Name/ Number</u>	<u>Restricted Length</u>
Whitehaven	Whinlatter Road Mirehouse	From its junction with Herdus Road to a point 67m north of its junction with Herdus Road.

4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
