

THE COUNTY OF CUMBRIA (VARIOUS ROADS, BARROW-IN-FURNESS)
(CONSOLIDATION AND MINOR AMENDMENT OF
TRAFFIC REGULATIONS) (ORDER 2001) VARIATION ORDER (NO.9) 2004

The County Council of Cumbria in exercise of its powers under Sections 1(1), 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53, 64 and 84 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order shall come into operation on 5th July 2004 and may be cited as The County of Cumbria (Various Roads, Barrow-in-Furness) (Consolidation and Minor Amendment of Traffic Regulations) (Order 2001) Variation Order (No. 9) Order 2004
2. For the purposes of this Order the expression “the 2001 Order” shall mean The County of Cumbria (Various Roads, Barrow-in-Furness) (Consolidation and Minor Amendment of Traffic Regulations) Order 2001
3. The 2001 Order shall have effect as though: -
 - (a) The length of road specified in Schedule I “Limited Waiting Parking Place, (At All Times), 10 mins, no return within 1 hour (permit holders exempt)” to this Order was added as item number 73 of Schedule I thereto;
 - (b) The lengths of road specified in Schedule IV “Limited Waiting Parking Place, Monday-Saturday, 8 am – 6 pm, 2 hours, no return within 4 hours” to this Order were added as item numbers 82 to 92 of Schedule IV thereto;
 - (c) The lengths of road specified in Schedule VII “Prohibition of Waiting At Any Time” to this Order were added as item numbers 1168 to 1180 inclusive of Schedule VII thereto;
 - (d) The lengths of road specified in Schedule VIII “Prohibition of Waiting, Monday – Friday, 8 am – 5 pm” to this Order were added as item numbers 7 to 10 inclusive of Schedule VIII thereto;
 - (e) The lengths of road specified in Schedule IX “Prohibition of Waiting, Monday – Saturday, 8 am – 6 pm” to this Order were added as item number 75 of Schedule IX thereto;
 - (f) The lengths of road specified in Schedule XV “Disabled Parking Place (At All Times)” to this Order were added as item numbers 47 to 48 inclusive of Schedule XV thereto;
 - (g) The length of road specified in Schedule XXIII “Prohibition of Stopping, Monday – Friday, 8 am – 5 pm, On School Keep Clear Markings” to this Order was added as item number 56 of Schedule XXIII thereto;

- (h) The lengths of road specified in Schedule XXXVI “30 Mph Speed Limit (At All Times)” to this Order were added as item numbers 2 and 3 of Schedule XXXVI thereto;
- (i) The entries specified in Schedule XLI “Residents Streets and Zone” to this Order were added to Schedule XLI thereto;
- (j) The length of road specified in Schedule IL “Limited Waiting Parking Place (At All Times) 10 mins, no return within 1 hour” to this Order was added as item number 2 of Schedule IL thereto;
- (k) The length of road specified in Schedule LIII “Parking Place for Police (At All Times)” was added as Schedule LIII thereto;
- (l) The following was added as “PART XXIA – PARKING PLACE FOR POLICE VEHICLES (AT ALL TIMES)”:-

PART XXIA

PARKING PLACE FOR POLICE VEHICLES (AT ALL TIMES)

- 70A. No person shall cause or permit any vehicle, other than a vehicle being used for police purposes, to wait at any time in the length of road specified in Schedule LIII to this Order.
- (m) The County of Cumbria (Various Roads, Barrow-in-Furness) (Consolidation and Minor Amendment of Traffic Regulations) Order 2001 was amended as follows: -
 - (i) Item No. 47 of Schedule II “Limited Waiting Parking Place, Monday – Saturday, 8 am – 6 pm, 2 hours, no return within 2 hours” which relates to Market Street, Dalton-in-Furness was deleted;
 - (ii) Item Nos 22, 23, 68, 455 and 608 of Schedule VII “Prohibition of Waiting At Any Time” which relate to Ainslie Street, Anchor Road, Ennerdale Drive and Island Road, Barrow-in-Furness, were deleted;
 - (iii) Item Nos 1 and 2 of Schedule VIII “Prohibition of Waiting, Monday – Friday, 8 am – 5 pm” which relate to Mikasa Street, Barrow-in-Furness, were deleted;
 - (iv) Item No 8 of Schedule XIII “Prohibition of Waiting 8 am – 8 pm” which relates to Wellington Street, Dalton-in-Furness, was deleted;
 - (v) Item No 3 of Schedule XXIII “Prohibition of Stopping, Monday – Friday 8 am – 5 pm on School Keep Clear Markings” which relates to Back Mikasa Street, Barrow-in-Furness, was deleted;
 - (vi) Item No. 41 of Schedule XV “Disabled Parking Place (At All Times)” which relates to Mount Pleasant, Dalton-in-Furness, was deleted;

(vii) Item No. 1146 of Schedule VII "Prohibition of Waiting At Any Time" which relates to Ennerdale Drive, Barrow-in-Furness, was deleted.

4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

SCHEDULE I

Limited Waiting Parking Place (At All Times) 10 mins no return within 1 hour (permit holders exempt)

- 73 Back Harrison Street / Greengate Street, Barrow-in-Furness, the north-west side from a point 8 metres south-west of its junction with Rawlinson Street to a point 5 metres north-east of its junction with Allison Street

SCHEDULE IV

Limited Waiting Parking Place Mon-Sat 8am-6pm 2 hours no return within 4 hours

- 82 Church Street, Barrow-in-Furness, the south-west side from a point 5 metres north of its junction with St George's Square for a distance of 25 metres in a north-west direction
- 83 Hibbert Road, Barrow-in-Furness, the north-east side from a point 5 metres west of its junction with Rutland Street for a distance of 48 metres in a north-west direction.
- 84 Hibbert Road, Barrow-in-Furness, the north-east side from a point 5 metres south-east of its junction with Rutland Street to a point 5 metres north-west of its junction with Settle Street

- 88 Longreins Road, Barrow-in-Furness, the east side from a point 5 metres north-east of its junction with Hibbert Road for a distance of 33 metres in a north-east direction
- 89 Longreins Road, Barrow-in-Furness, the north-east side from a point 5 metres south-east of its junction with Settle Street for a distance of 120 metres in a south-east direction
- 90 Longreins Road, Barrow-in-Furness, the south-west side from a point 5 metres south-east of its junction with Settle Street for a distance of 105 metres in a south-east direction
- 91 St George's Square, Barrow-in-Furness, the north-west side from a point 5 metres south-west of its junction with Church Street for a distance of 42 metres in a southerly direction
- 92 Westgate Road, Barrow-in-Furness, both sides, from a point 5 metres north west of its junction with Settle Street to a point 5 metres south east of its junction of Rutland Street

- 1172 Anchor Road, Barrow-in-Furness, the south-east side from a point 5 metres north-east of its junction with Abercorn Street to its junction with Ramsden Dock Road
- 1173 Dorset Street, Barrow-in-Furness, both sides from its junction with Ainslie Street for a distance of 10 metres in a south-west direction
- 1174 Ennerdale Drive, Barrow-in-Furness, the east side from its junction with Skelwith Drive to its junction with Dalton Lane
- 1175 Ennerdale Drive, Barrow-in-Furness, the west side from its junction with Dalton Lane for a distance of 15 metres in a northerly direction
- 1176 Ennerdale Drive, Barrow-in-Furness, the west side from a point 45 metres north of its junction with Dalton Lane to its junction with Skelwith Drive
- 1177 Greystoke Gardens, Barrow-in-Furness, both sides from its junction with Ennerdale Drive to its termination
- 1178 Hollow Lane, Barrow-in-Furness, both sides from its junction with Abbey Road for a distance of 50 metres in a south-east direction
- 1179 Island Road, Barrow-in-Furness, the south-west side from a point 10 metres east of its junction with Anchor Road to a point 5 metres north-west of its junction with Schooner Street
- 1180 Island Road, Barrow-in-Furness, the south-west side from its junction with Michaelson Road to a point 17 metres north-west of its junction with Schooner Street

- 7 Back Park Avenue, Barrow-in-Furness, the north-east side from its junction with Back Abbey Road to the (back) street end (to include the end of the cul-de-sac)
- 8 Back Park Avenue, Barrow-in-Furness, the south-west side from the street end for a distance of 10 metres in a north-west direction
- 9 Naiad Street, Barrow-in-Furness, the north-west side from its junction with Mikasa Street for a distance of 15 metres in a south-west direction
- 10 Naiad Street, Barrow-in-Furness, the south-east side from its junction with Mikasa Street for a distance of 35 metres in a south-west and then south-easterly direction

- 48 West View Road, Barrow-in-Furness, the north-east side from a point 5 metres south-east of its junction with Back Warwick Street / Abbey Road for a distance of 6.6 metres in a south-east direction

- 56 Naiad Street, Barrow-in-Furness, the north-west side from a point 15 metres south-west of its junction with Mikasa Street for a distance of 25.56 metres in a south-west and then south easterly direction

30mph Speed Limit (At All Times)

- 2 Cows Tarn Lane, Barrow-in-Furness, from its junction with North Scale to its junction with Solway Drive
- 3 Sandscale Park Road, Barrow-in-Furness, from a point 30 north-west of its junction with A590(T) Park Road for a distance of 285 metres in a westerly direction
