- The 2001 Order shall have effect as though the lengths of road specified in Schedule VII to this Order were added as item numbers 1532 to 1539 to Schedule VII "Prohibition of Waiting At Any Time" thereto. 3.
- The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament. 4.

Prohibition of Waiting (At All Times)

- 1532 Mill Lane, Barrow-in-Furness, the south-east side from a point 45 metres south-west of its junction with Promenade to its junction with Saunders Close for a distance of 49.38 metres in a south-westerly direction.
- 1533 Mill Lane, Barrow-in-Furness, the south-east side from its junction with Promenade to its junction with Saunders Close for a distance of 50 metres in a south- westerly direction.
- 1534 Mill Lane, Barrow-in-Furness, the north-west side from a point 60 metres south-west of its junction with Promenade for a distance of 56 metres in a south-westerly direction.
- 1535 Mill Lane, Barrow-in-Furness, the north-west side from a point 119.4 metres south-west of its junction with Promenade for a distance of 80 metres in a south-westerly direction.
- 1536 Mill Lane, Barrow-in-Furness, the north-west side from a point 202.9 metres south-west of its junction with Promenade for a distance of 26.5 metres in a south-westerly direction.
- 1537 Mill Lane, Barrow-in-Furness, the north-west side from a point 232.7 metres south-west of its junction with Promenade for a distance of 26 metres in a south-westerly direction.
- Saunders Close, Barrow-in-Furness, the north-east side from its junction with Mill Lane for a distance of 6 metres in a south-easterly direction.
- Saunders Close, Barrow-in-Furness, the south-west side from its junction with Mill Lane for a distance of 6 metres in a south-easterly direction.
