

THE COUNTY OF CUMBRIA (VARIOUS ROADS, CARLISLE URBAN AND RURAL
AREA)(CONSOLIDATION AND MINOR AMENDMENT OF
TRAFFIC REGULATIONS) (ORDER 2001) VARIATION ORDER (NO.1) 2002

The County Council of Cumbria in exercise of its powers under Sections 1(1), 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53 and 64 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order shall come into operation on 10th June 2002 and may be cited as The County of Cumbria (Various Roads, Carlisle Urban and Rural Area) (Consolidation and Minor Amendment of Traffic Regulations) (Order 2001) Variation Order (No. 1) Order 2002
2. For the purposes of this Order the expression "the 2001 Order" shall mean The County of Cumbria (Various Roads, Carlisle Urban and Rural Area) (Consolidation and Minor Amendment of Traffic Regulations) Order 2001
3. The 2001 Order shall have effect as though:-
 - (a) The lengths of road specified in Schedule A to this Order were added to Schedule IX "No Waiting At Any Time - Carlisle", thereto;
 - (b) The length of road specified in Schedule B to this Order was added to Schedule XXXIV "Designated Parking Places Zones A-F Inclusive - Carlisle" thereto.
4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.



NO WAITING AT ANY TIME – CARLISLE

<u>Street Name</u>	<u>Restriction</u>	<u>Street Side</u>	<u>Restricted Length</u>
Victoria Place	No Waiting At Any Time	North East	From a point 15m north west of its junction with St Aidan's Road for a distance of 164m in a north westerly direction;
Victoria Place	No Waiting At Any Time	South West	From a point 15m north west of its junction with St Aidan's Road for a distance of 157m in a north westerly direction.

DESIGNATED PARKING PLACES – ZONES A-F INCLUSIVE – CARLISLE

<u>Street Name</u>	<u>Restriction</u>	<u>Time</u>	<u>Street Side</u>	<u>Restricted Length</u>
St Aidan's Road	Residents Parking Zone B	Between the hours of 8am – 8 pm Monday to Friday and 8am - 6pm Saturday	North West	From a point 12m south west of its junction with Victoria Place to a point 40m north east of its junction with Warwick Road.
