

THE COUNTY OF CUMBRIA (VARIOUS ROADS, CARLISLE URBAN AND RURAL AREA)(CONSOLIDATION AND MINOR AMENDMENT OF TRAFFIC REGULATIONS) (ORDER 2001) VARIATION ORDER (CARLISLE CITY CENTRE) 2004

The County Council of Cumbria in exercise of its powers under Sections 1(1), 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53 and 64 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order shall come into operation on 7th June 2004 and may be cited as The County of Cumbria (Various Roads, Carlisle Urban and Rural Area) (Consolidation and Minor Amendment of Traffic Regulations) (Order 2001) Variation Order (Carlisle City Centre) Order 2004
2. For the purposes of this Order the expression "the 2001 Order" shall mean The County of Cumbria (Various Roads, Carlisle Urban and Rural Area) (Consolidation and Minor Amendment of Traffic Regulations) Order 2001
3. The 2001 Order shall have effect as though: -

- (a) The following was added to Part XI, Article 29, Schedule XXX "One Way Traffic":-

<u>Street Name</u>	<u>Restricted Length</u>
Crown Street Carlisle	From its junction with Lancaster Street to its junction with Botchergate.

- (b) The following was deleted from Schedule XXX "One Way Traffic": -

Rigg Street Carlisle	From its junction with Church Street to its junction with the B5299 Shaddongate

- (c) The following was added to Part II, Article 4 (10), Schedule IX "No Waiting At Any Time":-

<u>Street Name</u>	<u>Street Side</u>	<u>Restricted Length</u>
English Street	North-east	From a point 31m north west of its junction with Citadel Row for a distance of 30m.

- (d) The following was added as Article 18A and Part IVA "Loading Only": -

PART IVA

LOADING ONLY AREAS – AT ANY TIME

- 18A. Save as provided in Article 17 to this Order, no person shall cause or permit any vehicle to wait at any time in the lengths of road or sides of road specified in **Schedule XVIII** to this Order other than for the purpose of loading or unloading.
- (e) The following was added as Schedule XVIII "Loading Only Areas – At Any Time": -

<u>Street</u>	<u>Side</u>	<u>Restricted Length</u>
Victoria Viaduct Carlisle	West	From its junction with West Walls for a distance of 62 metres in a southerly direction
Victoria Viaduct Carlisle	East	From its junction with Bush Brow for a distance of 24 metres in a southerly direction

- (f) The following were added to Schedule XVIII "No Loading/Unloading – At Any Time": -

<u>Street</u>	<u>Side</u>	<u>Restricted Length</u>
Victoria Viaduct Carlisle	West	From a point 62 metres south of its junction with West Walls to its junction with the Viaduct Estate Road
Victoria Viaduct Carlisle	East	From a point 24 metres south of its junction with West Walls to its junction with James Street

- (g) The following was added to Schedule XVII "Disabled Persons Parking Places, 8.30 am – 6.00 pm, Monday to Saturday inclusive": -

<u>Street</u>	<u>Side</u>	<u>Restricted Length</u>
Castle Street Carlisle	North	From a point 10 metres west of its junction with St Mary's Gate for a distance of 32 metres in a westerly direction

- (h) The following entry in Zone C of Schedule XXXIV "Designated Parking Places – Zones A – F inclusive – Carlisle" was deleted

<u>Street</u>	<u>Side</u>	<u>Restricted Length</u>
Castle Street Carlisle	North	From a point 20 metres east of its junction with Finkle Street to a point 42 metres west of its junction with St Marys Gate

and replaced with the following: -

<u>Street</u>	<u>Side</u>	<u>Restricted Length</u>
Castle Street Carlisle	North	From a point 20 metres east of its junction with Finkle Street to a point 47 metres west of its junction with St Marys Gate

5. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

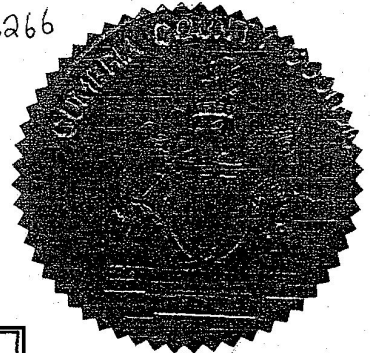
