

THE COUNTY OF CUMBRIA (VARIOUS ROADS, CARLISLE URBAN AND RURAL AREA)(CONSOLIDATION AND MINOR AMENDMENT OF TRAFFIC REGULATIONS) (ORDER 2001) VARIATION ORDER (NO. 6) 2006

The County Council of Cumbria in exercise of its powers under Sections 1(1), 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53 and 64 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order shall come into operation on 24th March 2006 and may be cited as The County of Cumbria (Various Roads, Carlisle Urban and Rural Area) (Consolidation and Minor Amendment of Traffic Regulations) (Order 2001) Variation Order (No. 6) Order 2006
2. For the purposes of this Order the expression "the 2001 Order" shall mean The County of Cumbria (Various Roads, Carlisle Urban and Rural Area) (Consolidation and Minor Amendment of Traffic Regulations) Order 2001
3. The 2001 Order shall have effect as though: -
 - (a) the lengths of road specified in Schedule IX to this Order were added to Schedule IX "No Waiting At Any Time – Carlisle" thereto.
 - (b) the lengths of road specified in Schedule XXVII to this Order were added to Schedule XXVII "Restriction of Waiting on School "Keep Clear" Markings, 8.00 am – 5.00 pm, Monday to Friday inclusive" thereto.
 - (c) the lengths of road specified in Schedule XXXIV to this Order were added to Schedule XXXIV "Designated Disc Parking Places – Zones A – G Inclusive – Carlisle" thereto.
 - (d) The lengths of road specified in Schedule XXXIV (Zone B) to this Order which relate to Victoria Place, Carlisle, were deleted in their entirety.
 - (e) Article 42(5) was amended to read: -
 - 42(5) (i) Without prejudice to the foregoing provisions of this Order and subject to Articles 56 herein and paragraph (ii) of this Article, any resident (as defined in this Order) may apply to the Council for the issue of a discretionary number of visitors permits allowing a bonafide visitor who is the Registered Keeper of that passenger vehicle (as defined in this Order) to leave that vehicle in a parking place for a maximum period of one calendar day and any such application shall be made on a form issued by and obtained from the Council and shall include the particulars and information required by such form to be supplied.
 - (ii) Not more than 60 visitors permits shall be issued in respect of any one premise at any one time.

- (iii) Notwithstanding the provisions of paragraph (ii) of this Article, the Council may exercise its discretion and issue more than 60 visitors permits in respect of any one premise.

(f) Article 50 was amended to read: -

50. Particulars to be included on Residents or Business Permits

- (1) A Residents or Business Permit shall be in writing and shall include the following particulars: -
- (a) the registration mark or marks of the vehicle in respect of which the permit has been issued;
 - (b) an authentication that the permit has been issued by the Council;
 - (c) the period which the permit shall remain valid;
 - (d) the name of the Zone for which the permit is valid; and
 - (e) an index number allocated by the Council for identification purposes;

Particulars to be included on Visitor's Permits

- (2) A Visitors Permit shall be in written in ink and shall include the following particulars: -
- (a) the registration mark or marks of the vehicle in respect of which the permit has been issued;
 - (b) an authentication that the permit has been issued by the Council;
 - (c) the date for which the vehicle shall be parked, being one calendar day;
 - (d) the name of the Zone for which the permit is valid; and
 - (e) an index number allocated by the Council for identification purposes;

(g) The following was added as Article 56A: -

Application for Guest House Visitors Permits

- 56A. (1) The proprietor of any Guest House, whether or not it has any off-street parking located within any of the zones specified in Schedule XXXIV to this Order, may apply to the Council for

the issue of a discretionary number of each or either of the following: -

- (a) one day visitors permits, or
- (b) weekly visitors permits

allowing a bonafide visitor of the Guest House who is the Registered Keeper of that passenger vehicle (as defined in this Order) to leave that vehicle in a parking place for the period specified on the permit.

(2) A Guest House Visitors Permit shall be written in ink and shall include the following particulars: -

- (a) the registration mark or marks of the vehicle in respect of which the permit has been issued;
- (b) an authentication that the permit has been issued by the Council;
- (c) the period for which the vehicle shall be parked;
- (d) the name of the Zone for which the permit is valid; and
- (e) an index number allocated by the Council for identification purposes;

(h) The heading to Part XVI was amended to read: -

APPLICATION FOR RESIDENTS, BUSINESS, VISITOR AND GUEST
HOUSE VISITOR PERMITS

(i) The following was added as Article 2(18)(A): -

“one calendar day” means a period of twenty-four hours commencing at 0001 hours to midnight inclusive.

(j) The heading to Part XV was amended to read: -

Designated Disc Parking Places (Zones A – G Inclusive)

(k) In Article 34(1) the words on the second line “is designated as a parking place” were replaced with “is designated as a disc parking place”.

(l) The heading to Schedule XXXIV was amended to read: -

(m) In column 2 of Schedule XXXIV the words “Residents Parking Zone A” shall be replaced with the words “Disc Parking, Residents of Zone A exempt”.

- (n) In column 2 of Schedule XXXIV the words "Residents Parking Zone B" shall be replaced with the words "Disc Parking, Residents of Zone B exempt".
- (o) In column 2 of Schedule XXXIV the words "Residents Parking Zone C" shall be replaced with the words "Disc Parking, Residents of Zone C exempt".
- (p) In column 2 of Schedule XXXIV the words "Residents Parking Zone D" shall be replaced with the words "Disc Parking, Residents of Zone D exempt".
- (q) In column 2 of Schedule XXXIV the words "Residents Parking Zone E" shall be replaced with the words "Disc Parking, Residents of Zone E exempt".
- (r) In column 2 of Schedule XXXIV the words "Residents Parking Zone F" shall be replaced with the words "Disc Parking, Residents of Zone F exempt".
- (s) In column 2 of Schedule XXXIV the words "Residents Parking Zone G" shall be replaced with the words "Disc Parking, Residents of Zone G exempt".
- (t) The heading to "Schedule XII No Waiting, 8.30 am – 6.00 pm, Monday – Saturday inclusive" was amended to read: -

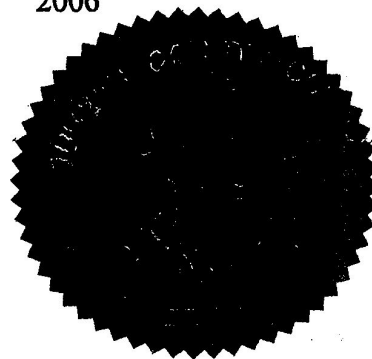
