THE COUNTY OF CUMBRIA (VARIOUS ROADS, CARLISLE URBAN AND RURAL AREA)(CONSOLIDATION AND MINOR AMENDMENT OF TRAFFIC REGULATIONS) (ORDER 2001) VARIATION ORDER (NO. 12) 2006

The County Council of Cumbria in exercise of its powers under Sections 1(1), 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53 and 64 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- 3. The 2001 Order shall have effect as though: -
 - (a) The following was added to Schedule XXVII Rural "Restriction of Waiting on School "Keep Clear" Markings, 8.00 am 5.00 pm, Monday to Friday inclusive:

Street Name	Side of Street	Restricted Length
Jackson Road Houghton	South side	From its junction with Houghton Road in an easterly direction for 25.56m.

(b) The following were added to Schedule IX Carlisle "No Waiting At Any Time": -

Street Name	Side of Street	Restricted Length
Castle Street	West side	From its junction with St Mary's Gate in a north westerly direction for a distance of 12m.
Lismore Place	West side	From a point 32m from its junction with Victoria Place in a southerly direction for 23m.

(c) The following were added to Schedule XXXIV "Designated Parking Places – Zones A-G inclusive" (Residents of Zone C Exempt): -

Street Name	Side of Street	Restricted Length
Rickergate	West side	From a point 16m from its
		junction with Corporation
		Street for a distance of 10m in
		a southerly direction.

4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
