THE COUNTY OF CUMBRIA (VARIOUS ROADS IN THE CITY OF CARLISLE) (PROHIBITION OF WAITING EXCEPT FOR HACKNEY CARRIAGES) (ORDER 2007) VARIATION (NO.1) ORDER 2007

The County Council of Cumbria in exercise of its powers under Sections 1, 2, 32 and 35 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- 1. This Order shall come into operation on 20 August 2007 and may be cited as The County of Cumbria (Various Roads in the City of Carlisle) (Prohibition of Waiting Except for Hackney Carriages) (Order 2007) Variation (No.1) Order 2007
- 2. For the purposes of this Order the expression "the 2007 Order" shall mean The County of Cumbria (Various Roads in the City of Carlisle) (Prohibition of Waiting Except for Hackney Carriages) Order 2007
- 3. The 2007 Order shall have effect as though: -
 - (a) In Article 2 "prescribed hours" was amended to read: -

"prescribed hours" means: -

- in relation to Nos. 3. 4, 5, 6, 7 and 14 inclusive of Schedule 1 to this Order, 24 hours a day, seven days a week;
- (b) in relation to No. 2 of Schedule 1 to this Order, between the hours of 9 pm on one day and 6 am the following day, seven days a week;
- (c) in relation to No. 1 of Schedule 1 to this Order, between the hours of 6 pm on any day and 8.30 am the following day, seven days a week; and
- (d) in relation to Nos. 8, 9, 10, 11, 12, and 13, between Midnight and 5 am the following day, seven days a week.
- (b) the following entries were added to Schedule 1 "Prohibition of Waiting Except for Hackney Carriages": -
