

THE COUNTY OF CUMBRIA (VARIOUS ROADS, CARLISLE URBAN AND RURAL AREA)(CONSOLIDATION AND MINOR AMENDMENT OF TRAFFIC REGULATIONS) (ORDER 2001) VARIATION ORDER (NO. 26) 2008

The County Council of Cumbria in exercise of its powers under Sections 1(1), 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53 and 64 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order shall come into operation on 28 April 2008 and may be cited as The County of Cumbria (Various Roads, Carlisle Urban and Rural Area) (Consolidation and Minor Amendment of Traffic Regulations) (Order 2001) Variation Order (No. 26) Order 2008
2. For the purposes of this Order the expression “the 2001 Order” shall mean The County of Cumbria (Various Roads, Carlisle Urban and Rural Area) (Consolidation and Minor Amendment of Traffic Regulations) Order 2001
3. The 2001 Order shall have effect as though: -

- (a) The following was added as Article 18B: -

P, person shall cause or permit
any vehicle to wait between the hours of 8.30 am and 6:00 pm on any day, in
the lengths of road or sides of road specified in Schedule XVIII B to this
Order, other than for the purpose of loading or unloading.

- (b) The following was added as Schedule XVIII B – “Loading Only Areas – 8.30 am – 6.00 pm Every Day”: -

<u>Street Name</u>	<u>Side of Street</u>	<u>Restricted Length</u>
Wilfred Street	North West	From a point 5m from its junction with Cecil Street, extending for a distance of 12.5m in a north-easterly direction.

- (c) The following was added as Article 9 (3): -

9. (3) That part of the road specified in **Schedule XVIIIA** to this Order is authorised to be used between the hours of 6.00 pm on any day and 8.30 am the following day, subject to Articles 10 and 11 of this Order, as a parking place for a disabled person's vehicle which displays a disabled person's badge and a parking disc in the relevant position.

- (d) Articles 10 and 11(1) were amended to include reference to Schedule XVIIA.

- (e) The following was added as Schedule XVIIA "Disabled Persons Parking Places, 6.00 pm – 8.30 am Every Day: -

<u>Street Name</u>	<u>Side of Street</u>	<u>Restricted Length</u>
Wilfred Street	North West	From a point 5m from its junction with Cecil Street, extending for a distance of 12.m in a north-easterly direction.

- (f) The following entry in Zone C of Schedule XXXIX "Designated Parking Places – Zones A – H inclusive" was deleted: -

<u>Street Name</u>	<u>Side of Street</u>	<u>Restricted Length</u>
Wilfred Street	North Side	From a point 15 metres south west of its junction with Portland Square (south west section) to a point 15 metres north east of its junction with Cecil Street

and replaced with the following: -

<u>Street Name</u>	<u>Side of Street</u>	<u>Restricted Length</u>
Wilfred Street	North Side	From a point 15 metres south west of its junction with Portland Square (south west section) for a distance of 10 metres in a south westerly direction.

4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
