

THE COUNTY OF CUMBRIA (VARIOUS ROADS IN THE CITY OF CARLISLE)
(PROHIBITION OF WAITING EXCEPT FOR HACKNEY CARRIAGES) (ORDER 2007)
VARIATION (NO.3) ORDER 2009

The County Council of Cumbria in exercise of its powers under Sections 1, 2, 32 and 35 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and Part 6 of the Traffic Management Act 2004, and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order shall come into operation on 23 February 2009 and may be cited as The County of Cumbria (Various Roads in the City of Carlisle) (Prohibition of Waiting Except for Hackney Carriages) (Order 2007) Variation (No.3) Order 2009
2. For the purposes of this Order the expression "the 2007 Order" shall mean The County of Cumbria (Various Roads in the City of Carlisle) (Prohibition of Waiting Except for Hackney Carriages) Order 2007
3. The 2007 Order shall have effect as though:
 - (a) the following entry in Schedule 1 "Prohibition of Waiting Except for Hackney Carriages" was deleted: -

7	Portland Place	South East	From a point 47.5m south west of its junction with Cecil Street for a distance of 33.5m in a south westerly direction	24 Hours	5

- (b) The following entry in Schedule 9 "No Waiting At Any Time" to The County of Cumbria (Various Roads, Carlisle Urban and Rural Area) (Consolidation and Minor Amendment of Traffic Regulations) Order 2001, was hereby deleted: -

<u>Street Name</u>	<u>Side</u>	<u>Restricted Length</u>
Portland Place	South East	From its junction with Botchergate for a distance of 10m in a north easterly direction.

and replaced with the following: -

<u>Street Name</u>	<u>Side</u>	<u>Restricted Length</u>
Portland Place	South East	From its junction with Botchergate for a distance of 51m in a north easterly direction.

4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
