THE COUNTY OF CUMBRIA (VARIOUS ROADS, CARLISLE URBAN AND RURAL AREA)(CONSOLIDATION AND MINOR AMENDMENT OF TRAFFIC REGULATIONS) (ORDER 2001) (EXPERIMENTAL VARIATION) (NO. 33) ORDER 2009

The County Council of Cumbria in exercise of its powers under Sections 9 and 10 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- 1. This Order shall come into operation on 1 September 2009 and may be cited as The County of Cumbria (Various Roads, Carlisle Urban and Rural Area) (Consolidation and Minor Amendment of Traffic Regulations) (Order 2001) (Experimental Variation) (No. 33) Order 2009
- 2. For the purposes of this Order the expression "the 2001 Order" shall mean The County of Cumbria (Various Roads, Carlisle Urban and Rural Area) (Consolidation and Minor Amendment of Traffic Regulations) Order 2001
- 3. The 2001 Order shall have effect as though: -

DESIGNATED DISC PARKING PLACES - DALSTON

Use of the Highway and Disc Parking Place

- Each of the lengths of road or sides of road as specified in Schedule XXXIVA to this Order, is designated as a disc parking place and may be used subject to the following provisions of this Order as a parking place for such classes of vehicles as are defined in Column 2 of Schedule XXXIVB to this Order in such positions and on such days as set out in Column 1 to Schedule XXXIVB and during such days and prescribed hours as are specified in relation to that highway area or length or side of road in Columns 3 and 4 of Schedule XXXIVB hereto for not longer than the period specified in Column 5 of the said Schedule.
 - (2) Where in Schedule XXXIVB a parking place is designated as available for vehicles (of the specified class) and in the specified position, the driver of a motor vehicle shall not permit it to wait in that parking place unless it is of such class and in such position as specified.
 - (3) Where, within such parking place there is a sign or surface marking which indicates that a parking place is available only for a disabled persons vehicle, the driver of a vehicle shall not permit it to wait in that parking place unless it is a disabled persons vehicle.
 - (4) A disabled person being the driver of a vehicle shall not permit it to wait in a parking place designated under this Part of this Order unless a valid disabled persons badge is displayed in that vehicle, whereupon the parking provisions and restrictions set out in this Part of this Order which relate to the setting of a parking disc shall have no application.
 - (5) For the avoidance of doubt, the driver of any motor vehicle shall not cause or permit any vehicle to be left in a parking place designated under this Part of this Order during the days and prescribed hours of operation as set out herein without setting and displaying a parking disc.
 - (6) When the vehicle has left a parking place designated under this Part of this Order after waiting thereon the driver thereof shall not within twenty-four hours after its leaving that parking place permit it to wait again in or upon that parking place.

- 5. This Order will continue in force for a maximum of 18 months.
- 6. As permitted by Section 10(2) of the Act and for the reasons stated therein the Corporate Director of Environment of the Council is hereby authorised, after consultation with the Chief Constable and after giving such notice as the Secretary of State may direct, to make such modifications to or to suspend any provisions of this Order as appear to him essential.
- 7. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
