

THE COUNTY OF CUMBRIA (VARIOUS ROADS, DISTRICT OF EDEN)
(CONSOLIDATION OF TRAFFIC REGULATIONS) ORDER 2002

1. The Cumbria County Council hereby give notice that on 20th December 2002 it made the above Order under Sections 1(1), 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53 and 64 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984.
2. The Order will come into operation on 6th January 2003 and its effect will be to consolidate the provisions of the Traffic Regulation Orders detailed below into one concise Order:-

If you wish to question the validity of the Order or of any provisions contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 or on the grounds that any requirement of that Act or any instrument made thereunder has not been complied with in relation to the Order, you may within six weeks of 20th December 2002 apply to the High Court for this purpose.
