

THE COUNTY OF CUMBRIA (VARIOUS ROADS, DISTRICT OF EDEN)  
(CONSOLIDATION OF TRAFFIC REGULATIONS) (ORDER 2003)  
VARIATION ORDER (NO.1) 200

The County Council of Cumbria in exercise of its powers under Sections 1(1), 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53 and 64 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order shall come into operation on <sup>16<sup>th</sup> June 2003.</sup> ~~XX~~ and may be cited as The County of Cumbria (Various Roads, District of Eden) (Consolidation of Traffic Regulations) (Order 2003) Variation Order (No. 1) Order 200
2. For the purposes of this Order the expression "the 2003 Order" shall mean The County of Cumbria (Various Roads, District of Eden) (Consolidation of Traffic Regulations) Order 2003
3. The 2003 Order shall have effect as though:-
  - (a) The following was added as PART XXIA and Article 100A: -

**PART XXIA**

PENRITH RESTRICTED ZONE

- 100A. Notwithstanding the foregoing provisions of this Order and for the avoidance of doubt, the lengths of road specified in columns 1, 2 and 3 of Schedule 76A hereto, which also appear in the Schedules specified in column 4, lie within the Penrith Restricted Zone as indicated by traffic signs conforming to diagram 637.2 (varied to read "Restricted Zone") and diagram 664 of the 1994 Regulations and as such are not subject to the requirement that there be yellow or white lines (as applicable) to indicate the type of restriction.

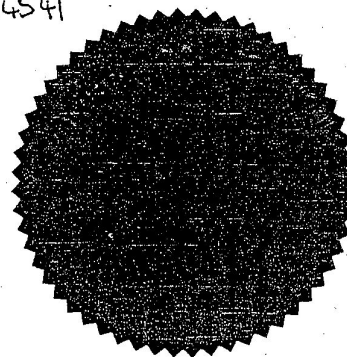
