

THE COUNTY OF CUMBRIA (VARIOUS ROADS, DISTRICT OF EDEN) (CONSOLIDATION OF TRAFFIC REGULATIONS) (ORDER 2003) VARIATION ORDER (NO.2) (PART 1 OF 2) 2004

The County Council of Cumbria in exercise of its powers under Sections 1(1), 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53 and 64 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- 1. This Order shall come into operation on 29th March 2004 and may be cited as The County of Cumbria (Various Roads, District of Eden) (Consolidation of Traffic Regulations) (Order 2003) Variation Order (No. 2) (Part 1 of 2) 2004
- 2. For the purposes of this Order the expression "the 2003 Order" shall mean The County of Cumbria (Various Roads, District of Eden) (Consolidation of Traffic Regulations)
 Order 2003
- 3. The 2003 Order shall have effect as though:-
 - (a) The following were added to Schedule 17 Part A Penrith "No Waiting At Any Time": -

| Location | Side | Restricted Length |
|-----------------|------|--|
| Tynefield Drive | East | From its junction with Bridge Lane to a point 125m north west of that junction |
| Tynefield Drive | East | From a point 232 north west of its junction with Bridge Lane to a point 378m north west of that junction |
| Tynefield Drive | West | From its junction with Bridge Lane to a point 140m north of that junction |
| Tynefield Drive | West | From a point 140m north west of its junction with Bridge Lane to a point 182m north of that junction |

(b) The following was added as Article 2(48): -

"Zone G" includes the following streets: -

Entire length of Tynefield Drive from its junction with Bridge Lane.

(c) Article 14 (1) (d) was amended to include reference to Schedule 6A.

- (d) Article 15 (1) (d) was amended to include reference to Schedule 6A.
- (e) Article 27 (6) was amended to include reference to Schedule 6A.
- (f) The following was added as Schedule 6A: -

Schedule 6A – Disc Parking Places: Monday – Friday, 8 am – 6 pm, Waiting Limited to 2 Hours, Return Prohibited within 2 Hours (Permit Holders G and Disabled Badge Holders Exempt)

- (g) Article 21 (3) was amended to read as follows: -
 - (i) Residents of streets specified in Zone A shall be exempt from the waiting restrictions in the parking places specified in Schedules 1, 2, 3, 3a and 6.
 - (ii) Residents of streets specified in Zone B shall be exempt from the waiting restrictions in the parking places specified in Schedule 4 (only to the extent indicated in column 6 thereof) and Schedule 39.
 - (iii) Residents of streets specified in Zone C shall be exempt from the waiting restrictions in the parking places specified in Schedule 4 (only to the extent indicated in column 6 thereof) and Schedule 40.
 - (iv) Residents of streets specified in Zone D shall be exempt from the waiting restrictions in the parking places specified in Schedule 5.
 - (v) Residents of streets specified in Zone E shall be exempt from the waiting restrictions in the parking places specified in Schedule 41.

- (vii) Residents of streets specified in Zone F shall be exempt from the waiting restrictions in the parking places specified in Schedule 42.
- (viii) Residents of streets specified in Zone G shall be exempt from the waiting restrictions in the parking places specified in Schedule 6A.
- (h) Article 21(4) was amended to refer to Schedule 39 in place of Schedule 43.
- (i) Article 21(5) was amended to refer to Schedule 40 in place of Schedule 44.
- (j) Article 21(6) was amended to refer to Schedule 41 in place of Schedule 45
- (k) Article 21(7) was amended to refer to Schedule 42 in place of Schedule 46.
- 4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
