

THE COUNTY OF CUMBRIA (VARIOUS ROADS, BARROW-IN-FURNESS)  
(CONSOLIDATION AND MINOR AMENDMENT OF  
TRAFFIC REGULATIONS) (ORDER 2001) VARIATION ORDER (NO.28) 2012

The County Council of Cumbria in exercise of its powers under Sections 1(1), 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53, 64 and 84 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order shall come into operation on 10 September 2012 and may be cited as The County of Cumbria (Various Roads, Barrow-in-Furness) (Consolidation and Minor Amendment of Traffic Regulations) (Order 2001) Variation Order (No. 28) Order 2012
2. For the purposes of this Order the expression "the 2001 Order" shall mean The County of Cumbria (Various Roads, Barrow-in-Furness) (Consolidation and Minor Amendment of Traffic Regulations) Order 2001
3. The 2001 Order shall have effect as though:-
  - (a) the lengths of road specified in Schedule VII to this Order were added as item numbers 1540 to 1546 to Schedule VII "Prohibition of Waiting At Any Time" thereto; and
  - (b) The following entry in Schedule XXXV "20 mph Speed Limit (At All Times)" was deleted: -

Hindpool Road, Barrow-in-Furness

Holker Street

From a point 11.5 metres north-west of its junction with Dryden Street for a distance of 600 metres in a north-westerly direction.

and replaced with the following: -

Hindpool, Barrow-in-Furness

Holker Street (U6170)

From a point 11.5 metres north-west of its junction with Dryden Street (U6184) for a distance of 775 metres in a north-westerly direction.

4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

**SCHEDULE VII**  
**Prohibition of Waiting (At All Times)**

Hindpool, Barrow-in-Furness

- 1540 Holker Street (U6170), Barrow-in-Furness on the east side from a point 108 metres south of its junction with Devonshire Road (U6133) for a distance of 64 metres in a southerly direction.
- 1541 Holker Street, Barrow-in-Furness on the west side from a point 91 metres south of its junction with Wilkie Road (U6133) for a distance of 85 metres in a southerly direction.
- 1542 Holker Street, Barrow-in-Furness on the south-west side from its junction with Chatsworth Street (U6172) for a distance of 47 metres in a north-westerly direction.
- 1543 Holker Street, Barrow-in-Furness on the south-west side from a point 62 metres north-west of its junction with Chatsworth Street (U6172) for a distance of 30 metres in a north-westerly direction.
- 1544 Holker Street, Barrow-in-Furness on the south-west side from a point 98 metres north-west of its junction with Chatsworth Street (U6172) for a distance of 31 metres in a north-westerly direction.
- 1545 Holker Street, Barrow-in-Furness on the south-west side from its junction with Chatsworth Street (U6172) for a distance of 16.5 metres in a south-easterly direction.
- 1546 Holker Street, Barrow-in-Furness on the north-east side from a point 18 metres south-east of the boundary of No.s 136/138 Holker Street for a distance of 156 metres in a north-westerly direction.
