

THE COUNCIL OF CUMBRIA (VARIOUS ROADS, BARROW-IN-FURNESS)
TRAFFIC REGULATIONS (CONSOLIDATION AND MINOR AMENDMENT OF)
2001 VARIATION ORDER (NO.30) 2013

The County Council of Cumbria in exercise of its powers under Sections 1(1), 2(1) to (4), 19, 32, 35, 35A, 38, 45, 46, 47, 49, 51, 53, 64 and 84 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Constable of Cumbria in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order shall come into operation on 4 November 2013 and may be cited as The County of Cumbria (Various Roads, Barrow-in-Furness) (Consolidation and Minor Amendment of Traffic Regulations) (Order 2001) Variation Order (No.30) Order 2013
2. For the purposes of this Order the expression "the 2001 Order" shall mean The County of Cumbria (Various Roads, Barrow-in-Furness) (Consolidation and Minor Amendment of Traffic Regulations) Order 2001
3. The 2001 Order shall have effect as though:-
 - (a) the length of road specified in Schedule IV to this Order was added as item number 182 to Schedule IV "Limited Waiting Parking Place, Mon-Sat, 8 am – 6 pm, 2 hours no return within 4 hours (Permit holders exempt)";
 - (b) the lengths of road specified in Schedule VII to this Order were added as item numbers 1597 to 1601 inclusive to Schedule VII "Prohibition of Waiting At Any Time" thereto;
 - (c) the length of road specified in Schedule XXXVII to this Order was added as item number 97 to Schedule XXXVII "One-Way (At All Times)" thereto;
 - (d) Item numbers 657 and 1556 of Schedule VII "Prohibition of Waiting (At All Times)", which relate to Lonsdale Street and School Street, Barrow-in-Furness, were deleted in their entirety;
 - (e) Item number 180 of Schedule IV "Limited Waiting Parking Place, Mon-Sat, 8 am – 6 pm, 2 hours no return within 4 hours (permit holders exempt)", which relates to School Street, Barrow-in-Furness, was deleted in its entirety.
4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

SCHEDULE IV

Limited Waiting Parking Place, Mon-Sat, 8 am – 6 pm, 2 hours, no return within 4 hours (permit holders exempt)

- 182 Lonsdale Street, Barrow-in-Furness, the north-west side from a point 22 metres north-east of its junction with Church Street to a point 19 metres south-west of its junction with School Street.

SCHEDULE VII

Prohibition of Waiting (At All Times)

- 1597 Lonsdale Street, Barrow-in-Furness, the south-east side from its junction with Church Street to its junction with School Street for its entire length.
- 1598 Lonsdale Street, Barrow-in-Furness, the north-west side from its junction with School Street for a distance of 19 metres in a south-westerly direction.
- 1599 Lonsdale Street, Barrow-in-Furness, the north-west side from its junction with Church Street for a distance of 24.00 metres in a north-easterly direction.
- 1600 School Street, Barrow-in-Furness, the south-west side from a point 52 metres north-west of its junction with Lonsdale Street for a distance of 18.00 metres in a south-easterly direction.
- 1601 School Street, Barrow-in-Furness, the south-west side from its junction with Lonsdale Street for a distance of 18.00 metres in a north-westerly direction.

SCHEDULE XXXVII

One Way (At All Times)

- 97 Lonsdale Street, Barrow-in-Furness, from its junction with School Street to its junction with Church Street for its entire length in a south-westerly direction.
