THE BOROUGH OF DACORUM (VARIOUS ROADS, BERKHAMSTED) (PROHIBITION AND RESTRICTION OF WAITING) (NO. 1) ORDER 2000

DACORUM BOROUGH COUNCIL pursuant to arrangements made under s.101 of the Local Government Act 1972 with the County Council of Hertfordshire in exercise of the powers of the said County Council under ss.1(1) and (2), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984 ("the Act") and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the said Act hereby make the following Order:

1. The following are hereby revoked:

The County of Hertford (Station Area, Berkhamsted) (Prohibition of Waiting) Order 1969 as it relates to the North side of Bridgewater Road.

The County of Hertford (Various Streets, Berkhamsted) (Prohibition of Waiting) Order 1972 as it relates to Clarence Road and the North side of Bridgewater Road.

The Dacorum Borough Council (Various Roads) (Prohibition and Restriction of Waiting) Order (No. 1) 1985 as it relates to the South side of Bridgewater Road.

In this Order:

"disabled person's vehicle" has the same meaning as in s.142(1) of the Act of 1984:

"disabled person" badge has the same meaning as in s.142(1) of the Act of 1984;

"parking disc" means a disc, issued by a local authority, 125 mm square, coloured orange, and capable of showing the quarter hour period during which a period of waiting begins; and

"relevant position" means

- (a) A vehicle displays a disabled person's badge issued before 2 March 1992 in the relevant position if:
 - (i) in the case of a vehicle fitted with a front windscreen, the badge be exhibited thereon on the near side of or immediately behind the windscreen and with its front facing forward so as to be legible from outside the vehicle; or

- (ii) in the case of a vehicle not fitted with a front windscreen, the badge is exhibited in a conspicuous position on the vehicle.
- (b) A vehicle displays a disabled person's badge issued on or after 2 March 1992 in the relevant position if:
 - in the case of a vehicle fitted with a dashboard or fascia panel, the badge is exhibited thereon so that Part 1 of the badge is legible from outside the vehicle; or
 - (ii) in the case of a vehicle not fitted with a dashboard or fascia panel, the badge is exhibited in a conspicuous position on the vehicle so that Part 1 of the badge is legible from outside the vehicle.
- (c) A vehicle displays a parking disc in the relevant position if:
 - (i) in the case of a vehicle fitted with a dashboard or fascia panel, the disc is exhibited thereon so that the quarter hour period during which the period of waiting began is legible from outside the vehicle; or
 - (ii) in the case of a vehicle not so fitted, the disc is exhibited in a conspicuous position on the vehicle so that the quarter hour period during which the period of waiting began is legible from outside the vehicle.
- 3. Save as provided in Article 5 of this Order no person shall, except upon the direction or with the permission of a Police Constable in uniform, or of a Traffic Warden, cause or permit any vehicle to wait between the hours of 8.30 am and 6.30 pm Monday to Saturday in the lengths of road specified in Schedule 1 to this Order.
- 4. Save as provided in Article 5 of this Order, no person shall, except upon the direction or with the permission of a Police Constable in uniform or of a Traffic Warden, cause or permit any vehicle to wait between the hours of 11 am and 12 noon Monday to Friday in the lengths of road specified in Schedule 2 to this Order.
- 5. Nothing in Articles 3 and 4 of this Order shall render it unlawful to cause or permit any vehicle to wait in the lengths of road specified therein for so long as may be necessary to enable:
 - (a) a person to board or alight from the vehicle;
 - (b) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely:
 - (i) building, industrial and demolition operations;
 - (ii) the removal of any obstruction to traffic;

- (iii) the maintenance, improvement or reconstruction of the said length of road;
- (iv) the laying, erection, alteration or repair in or on land adjacent to the said length of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus defined in paragraph 1 (1) of the Telecommunications Code contained in Schedule 2 of the Telecommunications Act 1984;
- (v) Fire Brigade, Ambulance or Police purposes;
- (c) the vehicle, if it cannot be conveniently used for such purposes in any other road, to be used in the service of a local authority or of a water authority in pursuance of statutory powers or duties;
- (d) the vehicle to be used for the purpose of delivering or collecting postal packets as defined in s.87 of the Post Office Act 1953.
- Nothing in Articles 3 and 4 of this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge, and a parking disc (on which the driver, or other person in charge of the vehicle, has marked the time at which the period of waiting began) to wait in the lengths of road referred to in the said Articles for a period not exceeding 3 hours (not being a period separated by an interval of less than 1 hour from a previous period of waiting in the same length of road).
- Nothing in Articles 3 and 4 of this Order shall render it unlawful to cause or permit any vehicle to wait for so long as may be necessary for the purpose of enabling goods to be loaded on or unloaded from the vehicle in the lengths of road specified in the Schedules to this Order.

The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

The restrictions imposed by this Order shall be in addition to and not in the derogation from any restriction or requirement imposed by any Regulations made or having effect as if made under the Act of 1984 or by a runder any other enactment.

This Order shall come into operation on 9 August 2000 and may be cited as the Borough of Dacorum (Various Roads, Berkhamsted) (Prohibition and Restriction of Waiting) (No. 1) Order 2000.

SCHEDULE 1

NO WAITING 8.30 AM TO 6.30 PM MONDAY TO SATURDAY

Clarence Road, Berkhamsted

Both sides from its junction with Kings Road, eastwards for an approximate distance of 10 metres.

Bridgewater Road, Berkhamsted

North side from its junction with Brownlow Road, westwards to its westernmost junction with Castle Hill Avenue, an approximate distance of 350 metres

Chapel Street, Berkhamsted

North side from its junction with Bridge Street eastwards to a point approximately 10 metres west of its junction with Ravens Lane

Priory Gardens, Berkhamsted

South-east side:

- (a) from its junction with Chesham Road northeastwards for a distance of approximately 5 metres
- (b) from a point approximately 13 metres north-east of its junction with Chesham Road north-eastwards for an approximate distance of 33 metres

North side from its junction with Chesham Road eastwards for an approximate distance of 15 metres

SCHEDULE 2

NO WAITING 11 AM TO 12 NOON MONDAY TO FRIDAY

Bridgewater Road, Berkhamsted

North side from its westernmost junction with Castle Hill Avenue to its junction with Murray Road, an approximate distance of 90 metres

South side from a point approximately 210 metres west of its junction with Brownlow Road to its easternmost junction with South Park Gardens, an approximate distance of 290 metres

Castle Hill, Berkhamsted

Both sides from its junction with Brownlow Road to its junction with Murray Road, an approximate distance of 400 metres

Castle Hill Avenue, Berkhamsted

From a point approximately 65 metres north of its easternmost junction with Bridgewater Road to its westernmost junction with Bridgewater Road, an approximate distance of 310 metres

Castle Hill Close, Berkhamsted

Both sides, an approximate distance of 210 metres.
