THE HERTFORDSHIRE (VARIOUS ROADS, HEMEL HEMPSTEAD, BERKHAMSTED, TRING, ALDBURY and MARKYATE) (RESTRICTION OF WAITING) ORDER 2010 (AMENDMENT) ORDER 2012

The Hertfordshire County Council in exercise of their powers under Sections 1, 2 and 3 of the Road Traffic Regulation Act 1984 (which said Act of 1984 is hereinafter referred to as "the Act of 1984"), and Part IV of Schedule 9 of the Act of 1984 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984, hereby make the following Order:-

1. This Order may be cited as "The Hertfordshire (Various Roads, Hemel Hempstead, Berkhamsted, Tring and Markyate) (Restriction of Waiting) Order 2010 (Amendment) Order 2012" and shall come into operation on Monday 11 June 2012.
2. The provisions of The Hertfordshire (Various Roads, Hemel Hempstead, Berkhamsted, Tring and Markyate) (Restriction of Waiting) Order 2010 shall be amended so as to add into Schedule 1 of that Order, the lengths of road specified within the Schedule to this Order.
3. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
4. The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any other regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

| Halwick Close
(both sides) | from its junction with the north west kerbline of Anchor Lane north westwards for 9 metres. |
